HOUSE CONCURRENT RESOLUTION NO. 72

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND
4 SECTION 57-75-5, MISSISSIPPI CODE OF 1972, TO REVISE THE
5 DEFINITION OF THE TERM "PROJECT" UNDER THE MISSISSIPPI MAJOR
6 ECONOMIC IMPACT ACT; TO AMEND SECTION 57-75-15, MISSISSIPPI CODE
7 OF 1972, TO AUTHORIZE THE ISSUANCE OF BONDS FOR CERTAIN PROJECTS
8 UNDER THE MISSISSIPPI MAJOR ECONOMIC IMPACT ACT; TO AUTHORIZE THE
9 ISSUANCE OF STATE GENERAL OBLIGATION BONDS IN THE AMOUNT OF
10 \$14,500,000.00 TO PROVIDE FUNDS TO THE PONTOTOC UNION LEE ALLIANCE
11 TO ASSIST IN PAYING COSTS INCURRED FOR PURCHASING REAL PROPERTY
12 AND OPTIONS ON REAL PROPERTY, CONSTRUCTION AND DEVELOPMENT OF
13 BUILDINGS, FACILITIES, INFRASTRUCTURE AND OTHER IMPROVEMENTS TO
14 PROPERTY, AND CONDUCTING ENGINEERING, ENVIRONMENTAL AND RELATED
15 SURVEYS OR STUDIES, NECESSARY TO IMPROVE AND ENHANCE ANY SITE FOR
16 THE RECRUITMENT AND LOCATION OF A MAJOR ECONOMIC DEVELOPMENT
17 PROJECT; TO REQUIRE THE COMMITMENT OF A CERTAIN AMOUNT OF MATCHING
18 FUNDS BEFORE BONDS MAY BE ISSUED UNDER THIS ACT; AND FOR RELATED
19 PURPOSES."

20 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
21 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
22 Rules of the House and the Senate, including all the deadlines and
23 other provisions imposed by Joint Rule No. 40, are suspended for
24 the purpose of requesting the drafting, and the introduction,
25 consideration and passage, of a bill entitled "AN ACT TO AMEND
26 SECTION 57-75-5, MISSISSIPPI CODE OF 1972, TO REVISE THE
27 DEFINITION OF THE TERM "PROJECT" UNDER THE MISSISSIPPI MAJOR
28 ECONOMIC IMPACT ACT; TO AMEND SECTION 57-75-15, MISSISSIPPI CODE
29 OF 1972, TO AUTHORIZE THE ISSUANCE OF BONDS FOR CERTAIN PROJECTS
30 UNDER THE MISSISSIPPI MAJOR ECONOMIC IMPACT ACT; TO AUTHORIZE THE
31 ISSUANCE OF STATE GENERAL OBLIGATION BONDS IN THE AMOUNT OF
32 \$14,500,000.00 TO PROVIDE FUNDS TO THE PONTOTOC UNION LEE ALLIANCE
33 TO ASSIST IN PAYING COSTS INCURRED FOR PURCHASING REAL PROPERTY
