HOUSE CONCURRENT RESOLUTION NO. 81

1 A CONCURRENT RESOLUTION CONGRATULATING AND COMMENDING DR.
2 LYNN A. WRIGHT, UPON HER RETIREMENT AS HOLMES COMMUNITY COLLEGE
3 VICE PRESIDENT OF ADMISSIONS AND RECORDS AFTER 21 YEARS OF SERVICE
4 AT HOLMES COMMUNITY COLLEGE AND 27 YEARS IN EDUCATION.

5 WHEREAS, when Dr. Lynn A. Wright retired from Holmes
6 Community College as its Vice President of Admissions and Records,
7 the school lost one of its finest education professionals; and

8 WHEREAS, Dr. Wright's efforts to gain a higher education
9 began at Holmes Community College; and

10 WHEREAS, after graduating from Holmes Community College, she
11 went on to obtain her bachelor's degree in business education from
12 Mississippi State, her master's degree in business education and
13 marketing from Mississippi College, and her doctorate degree from
14 the University of Mississippi; and

15 WHEREAS, Dr. Wright's 27 year career in education has
16 benefited many other educational institutions; and

17 WHEREAS, from 1967 to 1981, she taught typing, shorthand,
18 accounting, business English and key punch at Draughon's College;
19 from 1982 until 1984, she taught sales and marketing in the
20 Jackson Public School System; she taught sales and marketing at
21 the Clinton Vocational Center before coming to the Holmes
22 Ridgeland Campus in 1985; and she was director of the workforce
23 training program for ten years at the Holmes Ridgeland Campus
24 before becoming dean in 2005; and

25 WHEREAS, during her career, Dr. Wright has been lovingly
26 supported by her husband, Elton, who also worked at Holmes
27 Community College as track coach; and

28 WHEREAS, during her retirement, her husband will lovingly
29 support her in ripping out their kitchen cabinets and building new
30 ones from two red oak trees cut from her home place near West; and

31 WHEREAS, it is the policy of this Legislature to recognize
32 and commend the dedicated service of educators such as Dr. Lynn A.
33 Wright:

34 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
35 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
36 THEREIN, That we do hereby commend and congratulate Dr. Lynn A.
37 Wright upon her retirement as Holmes Community College Vice
38 President Of Admissions And Records after 21 years of service at
39 Holmes Community College and 27 years in education.
