HOUSE RESOLUTION NO. 108

1 A RESOLUTION COMMENDING AND CONGRATULATING THE LONG BEACH
2 HIGH SCHOOL MOCK TRIAL TEAM ON WINNING THE 2007 HIGH SCHOOL MOCK
3 TRIAL COMPETITION.

5 state championship that was held in the Hinds County Court House
6 in Jackson, Mississippi, on March 2 and 3, 2007; and

25 state in the National High School Mock Trial Competition with
26 their great oratorical skills and knowledge of the rules of
27 evidence and civil procedure; and

29 Team, the school's second team placed in the top portion of the
30 state competition, and the second team members are as follows:
