## HOUSE RESOLUTION NO. 120

1 A RESOLUTION COMMENDING REPRESENTATIVE JAMES "JAMIE" R.  
2 FRANKS, JR., FOR HIS DEDICATED SERVICE AS A MEMBER OF THE HOUSE OF  
3 REPRESENTATIVES AND CONGRATULATING HIM UPON HIS RETIREMENT.

4 WHEREAS, the Mississippi House of Representatives will lose a  
5 friend and valued ally when Representative James "Jamie" R.  
6 Franks, Jr., retires after this 2007 legislative term; and

7 WHEREAS, at age 34, this Mooreville, Mississippi, resident  
8 has served in the House of Representatives since 1996, with  
9 extraordinary leadership and unwavering commitment to his  
10 district; and

11 WHEREAS, driven by an innate desire to improve the lives of  
12 the citizens of House District 19, which includes Itawamba, Lee  
13 and Tishomingo Counties, Representative Franks began serving as a  
14 legislator shortly after graduating from the University of  
15 Mississippi with a bachelor of arts degree in political science;

18 Mississippi citizens, he earned his juris doctorate from  
19 Mississippi College School of Law in 2000 while serving as a  
20 legislator, and has used his law degree to improve the lives of  
21 Mississippians in many ways; and

23 of North Mississippi Horticultural Services; and

24 WHEREAS, Representative Franks' passion for people, astute  
25 leadership skills and intelligence have been vital assets while  
26 serving as Chairman of the Conservation and Water Resources  
27 Committee, and as a member of the Ways and Means, Judiciary A,

28 House Management, Medical Malpractice Insurance, Public Health and  
29 Human Services, State Library and Tourism Committees; and

30 WHEREAS, during his legislative tenure, he has championed  
31 many issues, including fully funding K-12 public education,  
32 protecting individual property rights, protecting the environment  
33 and the effective use of alternative fuels; and

34 WHEREAS, he is lovingly supported in all his endeavors by his
