SENATE BILL NO. 2311

1	AN ACT TO AMEND SECTION 63-1-46, MISSISSIPPI CODE OF 1972, TO
2	ALLOW REINSTATEMENT OF A PERSON'S DRIVER'S LICENSE PURSUANT TO A
3	PAYMENT PLAN; AND FOR RELATED PURPOSES.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 63-1-46, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 63-1-46. (1) A fee of Twenty-five Dollars (\$25.00) shall be
- 8 charged for the reinstatement of a license issued pursuant to this
- 9 article to every person whose license has been validly suspended,
- 10 revoked or cancelled. This fee shall be in addition to the fee
- 11 provided for in Section 63-1-43, Mississippi Code of 1972.
- 12 (2) The funds received under the provisions of subsection
- 13 (1) of this section shall be deposited into the State General Fund
- 14 in accordance with Section 45-1-23, Mississippi Code of 1972.
- 15 (3) In addition to the fee provided for in subsection (1) of
- 16 this section, an additional fee of Seventy-five Dollars (\$75.00)
- 17 shall be charged for the reinstatement of a license issued
- 18 pursuant to this article to every person whose license has been
- 19 suspended or revoked under the provisions of the Mississippi
- 20 Implied Consent Law or as a result of a conviction of a violation
- 21 of the Uniform Controlled Substances Law under the provisions of
- 22 Section 63-1-71.
- 23 (4) The funds received under the provisions of subsection
- 24 (3) of this section shall be placed in a special fund hereby
- 25 created in the State Treasury. Monies in such special fund may be
- 26 expended solely to contribute to the Disability and Relief Fund
- 27 for members of the Mississippi Highway Safety Patrol such amounts

- 28 as are necessary to make sworn agents of the Mississippi Bureau of
- 29 Narcotics who were employed by such bureau prior to December 1,
- 30 1990, and who were subsequently employed as enforcement troopers
- 31 by the Department of Public Safety, full members of the retirement
- 32 system for the Mississippi Highway Safety Patrol with full credit
- 33 for the time they were employed as sworn agents for the
- 34 Mississippi Bureau of Narcotics. The Board of Trustees of the
- 35 Public Employees' Retirement System shall certify to the State
- 36 Treasurer the amounts necessary for the purposes described above.
- 37 The State Treasurer shall monthly transfer from the special fund
- 38 created pursuant to this subsection the amounts deposited in such
- 39 special fund to the Disability and Relief Fund for members of the
- 40 Mississippi Highway Safety Patrol until such time as the certified
- 41 amount has been transferred. At such time as the certified amount
- 42 has been transferred, the State Treasurer shall transfer any funds
- 43 remaining in the special fund created pursuant to this subsection
- 44 to the State General Fund and shall then dissolve such special
- 45 $\,$ fund. This subsection (4) shall stand repealed at such time when
- 46 the State Treasurer transfers funds and dissolves the special fund
- 47 account in accordance with the provisions of this subsection.
- 48 (5) The procedure for the reinstatement of a license issued
- 49 pursuant to this article that has been suspended for being out of
- 50 compliance with an order for support, as defined in Section
- 51 93-11-153, and the payment of any fees for the reinstatement of a
- 52 license suspended for that purpose, shall be governed by Section
- 53 93-11-157 or 93-11-163, as the case may be.
- 54 (6) The department is hereby authorized to reinstate a
- 55 person's driving privileges when the person provides the
- 56 department with certification from the court or clerk of court
- 57 issuing the order that resulted in the suspension of driving
- 58 privileges that the person has entered into a payment plan with
- 59 the court and has satisfied all other provisions of law relating
- 60 to the issuance and restoration of a driver's license.

61 **SECTION 2.** This act shall take effect and be in force from

62 and after July 1, 2007.
