SENATE BILL NO. 2342 (As Passed the Senate)

- AN ACT TO AMEND SECTION 69-15-19, MISSISSIPPI CODE OF 1972,
- 2 TO REVISE THE FUNDING OF THE ANIMAL CARE FUND TO INCLUDE QUALIFIED
- 3 NONPROFIT ORGANIZATIONS; TO AUTHORIZE THE MISSISSIPPI BOARD OF
- 4 ANIMAL HEALTH TO USE A PORTION OF THE FUNDS FOR ANNUAL
- 5 ADMINISTRATIVE EXPENSES; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 69-15-19, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 69-15-19. (1) As used in this section, the term "qualified
- 10 nonprofit organization" means an IRS tax-exempt 501(c)(3) or
- 11 similar nonprofit organization that has been approved by the
- 12 <u>Mississippi Board of Animal Health.</u>
- 13 <u>(2)</u> There is created in the State Treasury a special fund to
- 14 be known and designated as the "Animal Care Fund." There shall be
- 15 deposited in the fund:
- 16 (a) The additional fees collected from the issuance of
- 17 distinctive license tags under Section 27-19-56.18;
- 18 (b) Any gifts, grants, donations or matching money from
- 19 federal, state or local governmental bodies and private persons,
- 20 associations, groups or corporations making contributions to the
- 21 fund; and
- 22 (c) Any other monies as the Legislature may appropriate
- 23 or authorize to be deposited therein.
- 24 (3) The special fund created under subsection (1) of this
- 25 section shall be administered by the Mississippi Board of Animal
- 26 Health. Monies in the special fund shall be allocated and
- 27 distributed by the Mississippi Board of Animal Health to and among
- 28 the boards of supervisors of each of the counties * * *, the

- 29 governing authorities of municipalities in the state and qualified
- 30 nonprofit organizations. Monies allocated, distributed and
- 31 received by the boards of supervisors, governing authorities and
- 32 qualified nonprofit organizations may:
- 33 (a) * * * Be expended for the operation and support of
- 34 county or municipal agencies, boards or departments that provide
- 35 food, shelter and care, and/or spaying and neutering of lost,
- 36 abandoned or unwanted pets;
- 37 (b) * * * Be expended for the creation, development or
- 38 expansion of such agencies, boards or departments; or
- 39 (c) * * * Be donated by the boards of supervisors and
- 40 governing authorities to nonprofit groups, organizations and
- 41 associations that operate similar programs. However, priority for
- 42 expenditure of such monies shall be given to spaying and neutering
- 43 programs. None of such monies may be expended for euthanasia.
- 44 The Mississippi Board of Animal Health is authorized to use a
- 45 portion of the fund, in an amount not to exceed Two Thousand
- 46 Dollars (\$2,000.00) a year, to fund administrative expenses.
- 47 (4) The Mississippi Board of Animal Health shall adopt rules
- 48 and regulations governing the proper administration of the Animal
- 49 Care Fund, and establishing guidelines and criteria for the
- 50 distribution and allocation of monies in the fund, including
- 51 qualifications for those groups, organizations and associations
- 52 qualified to accept monies or to which boards of supervisors and
- 53 governing authorities may make donations.
- 54 **SECTION 2.** This act shall take effect and be in force from
- 55 and after July 1, 2007.
