8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
9	SECTION 1. Section 37-13-134, Mississippi Code of 1972, is
10	amended as follows:
11	37-13-134. (1) The Legislature recognizes that there is a
12	problem with Mississippi student inactivity and obesity * * *, and
13	therefore requires the following guidelines for school district
14	physical education, health education and fitness classes:
15	Kindergarten through Grade $8:$ one hundred fifty (150) minutes per
16	week of activity-based instruction as defined by the State Board
17	of Education and forty-five (45) minutes per week of health
18	education instruction; Grades 9 through 12: 1/2 Carnegie unit
19	requirement in physical education for graduation. All instruction
20	in physical education and health education must be based on the
21	most current state standards provided by the Mississippi State
22	Department of Education.
23	(2) * * * State-source funds shall be appropriated for * * *
24	the State Department of Education * * * to employ a physical
25	activity coordinator to assist districts on current and effective
26	practices and on implementation of physical education programs.
