12	(2) In any civil action founded on a check, draft or order		
13	made, drawn, issued, uttered or delivered in violation of Section		
14	97-19-55, the plaintiff, if he be a payee, endorser, holder or		
15	assignee, shall be entitled to recover, in addition to the face		
16	amount of the check, draft or order, damages in the following
