SENATE BILL NO. 2503

AN ACT TO AMEND SECTION 25-61-7, MISSISSIPPI CODE OF 1972, TO REVISE THE FEES FOR COSTS INCIDENT TO PROVIDING RECORDS UNDER THE PUBLIC RECORDS ACT; TO AMEND SECTION 25-61-15, MISSISSIPPI CODE OF 1972, TO INCREASE THE CIVIL PENALTY FOR WRONGFUL DENIAL OF ACCESS TO PUBLIC RECORDS; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 25-61-7, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 25-61-7. (1) Except as provided in subsection (2) of this
- 10 section, each public body may establish and collect fees
- 11 reasonably calculated to reimburse it for, and in no case to
- 12 exceed, the actual cost of searching, reviewing and/or duplicating
- 13 and, if applicable, mailing copies of public records. Such fees
- 14 shall be collected by the public body in advance of complying with
- 15 the request.
- 16 (2) A public body may establish a standard fee scale to
- 17 reimburse it for the costs of creating, acquiring and maintaining
- 18 a geographic information system or multipurpose cadastre as
- 19 authorized and defined under Section 25-61-1 et seq., or any other
- 20 electronically accessible data. Such fees must be reasonably
- 21 related to the cost of creating, acquiring and maintaining the
- 22 geographic information system, multipurpose cadastre or other
- 23 electronically accessible data, for the data or information
- 24 contained therein or taken therefrom and for any records, papers,
- 25 accounts, maps, photographs, films, cards, tapes, recordings or
- 26 other materials, data or information relating thereto, whether in
- 27 printed, digital or other format. In determining the fees or
- 28 charges under this subsection, the public body may consider the

- 29 type of information requested, the purpose or purposes for which
- 30 the information has been requested and the commercial value of the
- 31 information. However, charges for labor performed by employees of
- 32 the public body shall not exceed the lowest hourly pay scale of an
- 33 employee in the public body's administration office. An itemized
- 34 invoice for the fees or charges shall be presented at the time of
- 35 delivery to the person requesting the public records.
- 36 **SECTION 2.** Section 25-61-15, Mississippi Code of 1972, is
- 37 amended as follows:
- 38 25-61-15. Any person who shall willfully and knowingly deny
- 39 to any person access to any public record which is not exempt from
- 40 the provisions of this chapter shall be liable civilly in a sum
- 41 not to exceed One Thousand Dollars (\$1,000.00), plus all
- 42 reasonable expenses incurred by such person bringing the lawsuit.
- 43 **SECTION 3.** This act shall take effect and be in force from
- 44 and after July 1, 2007.
