## SENATE BILL NO. 2777

- AN ACT TO AMEND SECTION 43-13-407, MISSISSIPPI CODE OF 1972,
- TO PROVIDE FOR AN ANNUAL TRANSFER OF \$20,000,000.00 FROM THE 2
- HEALTH CARE TRUST FUND INTO THE HEALTH CARE EXPENDABLE FUND TO REFLECT THE DEPOSIT OF TOBACCO SETTLEMENT INSTALLMENT PAYMENTS 3

- FORMERLY MADE TO THE PARTNERSHIP FOR A HEALTHY MISSISSIPPI, INC.; 5
- 6 AND FOR RELATED PURPOSES.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 43-13-407, Mississippi Code of 1972, is 8
- 9 amended as follows:
- 10 43-13-407. (1) In accordance with the purposes of this
- article, there is established in the State Treasury the Health 11
- 12 Care Expendable Fund, into which shall be transferred from the
- Health Care Trust Fund the following sums: 13
- In fiscal year 2005, Four Hundred Fifty-six Million 14
- Dollars (\$456,000,000.00); 15
- In fiscal year 2006, One Hundred Eighty-six Million 16
- 17 Dollars (\$186,000,000.00);
- (c) In fiscal year 2007, One Hundred Forty-six Million 18
- 19 Dollars (\$146,000,000.00);
- 20 In fiscal year 2008, One Hundred Twenty-six Million (d)
- Dollars (\$126,000,000.00); 21
- 22 In fiscal year 2009, Eighty-six Million Dollars
- 23 (\$86,000,000.00);
- (f) In fiscal year 2010 and each fiscal year 24
- 25 thereafter, a sum equal to Twenty Million Dollars (\$20,000,000.00)
- plus the average annual amount of the dividends, interest and 26
- 27 other income, including increases in value of the principal,
- earned on the funds in the Health Care Trust Fund during the 28
- 29 preceding four (4) fiscal years.

- In any fiscal year in which interest, dividends and 30 (2) 31 other income from the investment of the funds in the Health Care Trust Fund are not sufficient to fund the full amount of the 32 annual transfer into the Health Care Expendable Fund as required 33 34 in subsection (1)(f) of this section, the State Treasurer shall 35 transfer from tobacco settlement installment payments an amount 36 that is sufficient to fully fund the amount of the annual 37 transfer.
- On March 6, 2002, the State Treasurer shall transfer the 38 39 sum of Eighty-seven Million Dollars (\$87,000,000.00) from the 40 Health Care Trust Fund into the Health Care Expendable Fund. 41 addition, at the time the State of Mississippi receives the tobacco settlement installment payments for each of the calendar 42 43 years 2002 and 2003, the State Treasurer shall deposit the full amount of each of those installment payments into the Health Care 44 45 Expendable Fund.
- 46 The total sum of Two Hundred Forty Million Dollars 47 (\$240,000,000.00) plus interest at the rate of five percent (5%) per annum shall be transferred into the Health Care Trust Fund 48 49 from the State General Fund during fiscal years 2008 through 2015 50 to repay the trust fund for Two Hundred Forty Million Dollars (\$240,000,000.00) of the total sum that is transferred from the 51 52 trust fund to the Health Care Expendable Fund during fiscal year 53 2005 under subsection (1)(a) of this section. The repayment shall 54 be made according to the following schedule: During each of fiscal years 2008 through 2014, the State Fiscal Officer shall 55 transfer from the General Fund to the Health Care Trust Fund the 56 57 sum of Thirty-eight Million Dollars (\$38,000,000.00), and during fiscal year 2015 the State Fiscal Officer shall transfer from the 58 59 State General Fund to the Health Care Trust Fund a sum in the amount certified by the State Treasurer as necessary to fully 60

repay the balance of the Two Hundred Forty Million Dollars

- 62 (\$240,000,000.00) plus interest at the rate of five percent (5%)
- 63 per annum.
- (5) All income from the investment of the funds in the
- 65 Health Care Expendable Fund shall be credited to the account of
- 66 the Health Care Expendable Fund. Any funds in the Health Care
- 67 Expendable Fund at the end of a fiscal year shall not lapse into
- 68 the State General Fund.
- (6) The funds in the Health Care Expendable Fund shall be
- 70 available for expenditure under specific appropriation by the
- 71 Legislature beginning in fiscal year 2000, and shall be expended
- 72 exclusively for health care purposes.
- 73 (7) The provisions of subsection (1) of this section may not
- 74 be changed in any manner except upon amendment to that subsection
- 75 by a bill enacted by the Legislature with a vote of not less than
- 76 three-fifths (3/5) of the members of each house present and
- 77 voting.
- 78 (8) Subsections (1), (2), (5) and (6) of this section shall
- 79 stand repealed on July 1, 2009.
- 80 **SECTION 2.** This act shall take effect and be in force from
- 81 and after July 1, 2007.
