SENATE BILL NO. 3053

AN ACT TO PROVIDE THAT THE DEPARTMENT OF FINANCE AND ADMINISTRATION SHALL CONVEY TO THE UNIVERSITY OF MISSISSIPPI 3 MEDICAL CENTER CERTAIN REAL PROPERTY KNOWN AS THE OLD FARMERS' MARKET AND LOCATED IN JACKSON, MISSISSIPPI; TO REQUIRE THAT THE UNIVERSITY OF MISSISSIPPI MEDICAL CENTER SHALL USE THE PROPERTY 5 6 FOR A RESEARCH PARK; TO REQUIRE THAT A PORTION OF THE PROPERTY 7 SHALL BE RESERVED EXCLUSIVELY FOR THE CONSTRUCTION OF THE MISSISSIPPI INDUSTRIES FOR THE BLIND FACILITY AND THE STATE RECORDS CENTER; TO PROVIDE THAT IF THE PROPERTY GENERALLY KNOWN AS 8 9 THE "MISSISSIPPI VETERANS MEMORIAL STADIUM PROPERTY," IS OFFERED 10 11 BY THE STATE OF MISSISSIPPI FOR SALE, LEASE OR OTHER CONVEYANCE OR TRANSFER, THE UNIVERSITY OF MISSISSIPPI MEDICAL CENTER SHALL HAVE 12 PREFERENCE IN OBTAINING THE PROPERTY; AND FOR RELATED PURPOSES. 13 14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 15 SECTION 1. Acting on behalf of the State of Mississippi, the 16 Department of Finance and Administration shall convey to the University of Mississippi Medical Center certain state-owned real 17 18 property, and any improvements, rights and appurtenances thereon, that is known as the old Farmers' Market and located in Jackson, 19 Mississippi, subject to the conditions set forth in this section, 20 which shall be specified with particularity in the conveyance 21 2.2 document: 23 The property shall be used by the University of Mississippi Medical Center exclusively as a research park, and if 24 25 the property is not so used within five (5) years from the effective date of this act, then the title to the property and all 26 improvements, rights and appurtenances thereon shall revert to and 27

- 47 1972, is offered for sale, lease or other conveyance or transfer,
- 48 by the State of Mississippi, at any time after the effective date
- 49 of this act, then the University of Mississippi Medical Center
- 50 shall have preference in any opportunities that may exist to
- 51 obtain the property.
