The following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 6 7 General Fund not otherwise appropriated, for the purpose of defraying the expenses of the Commission on Judicial Performance 8 of the State of Mississippi for the fiscal year beginning 9 July 1, 2007, and ending June 30, 2008.....\$ 379,092.00. 10 11 SECTION 2. The following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 12 Treasury to the credit of the Commission on Judicial Performance, 13 for the purpose of defraying the expenses of the Commission on 14 Judicial Performance of the State of Mississippi for the fiscal 15 year beginning July 1, 2007, and ending June 30, 2008..... 16 .....\$ 17 197,093.00. 18 SECTION 3. With the funds appropriated under the provisions of Sections 1 and 2, the following positions are authorized: 19 AUTHORIZED POSITIONS: 20 Full Time..... 5 21 Permanent: 22 Part Time..... 0 Time-Limited: Full Time..... 23 0 24 Part Time..... 0 25 Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law. 26

27 No general funds authorized to be expended herein shall be 28 used to replace federal funds and/or other special funds which are 29 being used for salaries authorized under the provisions of this 30 act and which are withdrawn and no longer available.

31 SECTION 4. It is the intention of the Legislature that the 32 Judicial Performance Commission shall maintain complete accounting 33 and personnel records related to the expenditure of all funds appropriated under this act and that such records shall be in the 34 same format and level of detail as maintained for Fiscal Year 35 36 2007. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2009 shall be submitted to 37 38 the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail provided 39 during the Fiscal Year 2008 budget request process. 40

SECTION 5. It is the intention of the Legislature that 41 42 whenever two (2) or more bids are received by this agency for the 43 purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, 44 45 quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to 46 47 the Mississippi Industries for the Blind whenever purchases are 48 made without competitive bids.

49 SECTION 6. In addition to all other funds heretofore 50 appropriated, the following sum is hereby appropriated out of any 51 money in the State Treasury to the credit of the Mississippi Commission on Judicial Performance for the purpose of funding 52 53 travel and the cost of additional hearings of the Commission for the period beginning upon passage and through June 30, 2007..... 54 20,000.00. 55 .....\$ 56 SECTION 7. The money herein appropriated shall be paid by

Officer shall issue his warrants upon requisitions signed by the
proper person, officer or officers, in the manner provided by law.
SECTION 8. This act shall take effect and be in force from
and after July 1, 2007, except for Section 6 which shall take
effect and be in force from and after its passage.
