5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. The following sum, or so much thereof as may be
7	necessary, is hereby appropriated out of any money in the State
8	General Fund not otherwise appropriated, for expenses of the
9	Executive Department, being the Governor's office and staff, for
10	the fiscal year beginning July 1, 2007, and ending June 30, 2008,
11	\$ 2,353,074.00.
12	SECTION 2. The following sum, or so much thereof as may be
13	necessary, is hereby appropriated out of any money in the State
14	Treasury to the credit of the Governor's Office for the purpose of
15	defraying the expenses incurred by the Executive Department, being
16	the Governor's office and staff, for the fiscal year beginning
17	July 1, 2007, and ending June 30, 2008\$ 651,810.00.
18	SECTION 3. Of the funds appropriated under the provisions of
19	Sections 1 and 2, the following positions are authorized:

- 37 **SECTION 5.** Of the funds appropriated under the provisions of

- Any escalations shall be made in accordance with the terms,

- 50 **SECTION 6.** It is the intention of the Legislature that
- 51 whenever two (2) or more bids are received by this agency for the

- 54 quality and service, the Mississippi Industries for the Blind
- 55 shall be given preference. A similar preference shall be given to

- 58 **SECTION 7.** The money herein appropriated shall be paid by
- 59 the State Treasurer out of any money in the State Treasury to the
- 60 credit of the proper fund or funds as set forth in this act, upon
- 61 warrants issued by the State Fiscal Officer; and the State Fiscal

- 62 Officer shall issue his warrants upon requisitions signed by the
- 63 proper person, officer or officers, in the manner provided by law.
- SECTION 8. This act shall take effect and be in force from
- 65 and after July 1, 2007.
