SENATE BILL NO. 3121
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION FOR THE SUPPORT AND
2 MAINTENANCE OF THE ALCORN STATE UNIVERSITY AGRICULTURAL PROGRAMS
3 FOR FISCAL YEAR 2008.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** The following sum, or so much thereof as may be
6 necessary, is hereby appropriated out of any money in the State
7 General Fund not otherwise appropriated, for the support and
8 maintenance of the Alcorn State University Agricultural Programs
9 for the fiscal year beginning July 1, 2007, and ending

10 June 30, 2008..... \$ 4,754,590.00.

11 **SECTION 2.** The following sum, or so much thereof as may be
12 necessary, is hereby authorized for expenditure out of any special
13 source funds which are collected by or otherwise become available,
14 for the support and maintenance of the Alcorn State University
15 Agricultural Programs for the fiscal year beginning July 1, 2007,
16 and ending June 30, 2008..... \$ 21,097.00.

17 **SECTION 3.** Of the funds appropriated in Section 2,
18 Twenty-one Thousand Ninety-seven Dollars (\$21,097.00) shall be
19 derived from funds in the Education Enhancement Fund deposited
20 pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of
21 1972.

22 **SECTION 4.** No general funds authorized to be expended herein
23 shall be used to replace federal funds and/or other special funds
24 which are being used for salaries which are withdrawn and no
25 longer available.

26 **SECTION 5.** It is the intention of the Legislature that the
27 agency's budget request for Fiscal Year 2009 shall be submitted to

28 the Joint Legislative Budget Committee in a format and level of
29 detail comparable to the format and level of detail provided
30 during the Fiscal Year 2008 budget request process.

31 **SECTION 6.** It is the intention of the Legislature that
32 whenever two (2) or more bids are received by this agency for the
33 purchase of commodities or equipment, and whenever all things
34 stated in such received bids are equal with respect to price,
35 quality and service, the Mississippi Industries for the Blind
36 shall be given preference. A similar preference shall be given to
37 the Mississippi Industries for the Blind whenever purchases are
38 made without competitive bids.

39 **SECTION 7.** It is legislative intent to ensure beneficial
40 information reaches as many Mississippians as possible. Further,
41 it is legislative intent that the expenditure of public funds for
42 this purpose be accomplished in an efficient and effective manner.

43 Therefore, state agencies as standard procedure, will observe
44 the following criteria:

45 (a) Develop goals and desired result for a campaign.

46 (b) Evaluate effectiveness through respected
47 advertising standards, including market reach and cost
48 effectiveness.

49 (c) Seek public service announcements, which would be
50 aired by media without cost.

51 (d) Itemize and justify professional assistance and
52 related expenses for creative and production costs outside of the
53 actual media expenditures.

54 (e) Utilize Mississippi-owned media companies when
55 feasible.

56 **SECTION 8.** Of the funds appropriated in Sections 1 and 2, an
57 amount of Three Hundred Fifty-five Thousand One Hundred Eighty
58 Dollars (\$355,180.00) shall be used for The Mississippi Natural
59 Products Association, Inc.

60 **SECTION 9.** The money herein appropriated shall be paid by
61 the State Treasurer out of any money in the State Treasury to the
62 credit of the proper fund or funds as set forth in this act, upon
63 warrants issued by the State Fiscal Officer; and the State Fiscal
64 Officer shall issue his warrants upon requisitions signed by the
65 proper person, officer or officers in the manner provided by law.

66 **SECTION 10.** This act shall take effect and be in force from
67 and after July 1, 2007.
