It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the 12 purchase of commodities or equipment, and whenever all things 13 stated in such received bids are equal with respect to price, 14 15 quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to 16 17 the Mississippi Industries for the Blind whenever purchases are 18 made without competitive bids. **SECTION 3.** It is legislative intent to ensure beneficial 19 20 information reaches as many Mississippians as possible. (5) Utilize Mississippi owned media companies when feasible. 33 SECTION 4. The money herein appropriated shall be paid by 34 the State Treasurer out of any money in the State Treasury to the 35 credit of the proper fund or funds as set forth in this act, upon 36 37 warrants issued by the State Fiscal Officer; and the State Fiscal 38 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 39 40 SECTION 5. This act shall take effect and be in force from and after July 1, 2007. 41
