10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:							
11	SECTION 1. The following sum, or so much thereof as may be							
12	necessary, is hereby appropriated out of any money in the State							
13	Treasury to the credit of the Mississippi Fair Commission's							
14	special fund account, to the Mississippi Fair Commission for the							
15	purposes of defraying the costs of prizes, premiums, judges and							
16	other actual and necessary costs of putting on the Dixie National							
17	Livestock Show at the State Fairgrounds in Jackson, Mississippi,							
18	for the fiscal year beginning July 1, 2007, and ending							
19	June 30, 2008\$ 954,150.00.							
20	SECTION 2. Of the funds appropriated under the provisions of							
21	Section 1, not more than the amounts set forth below shall be

37	SECTION 3. The following sums, or so much thereof as may be
38	necessary, are hereby appropriated out of any money in the State
39	General Fund, not otherwise appropriated, to the Mississippi Fair
40	Commission as follows:
41	(a) For the support of annual roundup shows for junior
42	exhibitors of junior steers, junior breeding cattle, beef cattle,
43	dairy cattle, hogs, sheep and goats, for the fiscal year beginning
44	July 1, 2007, and ending June 30, 2008
45	\$ 69,720.00.
46	(b) To supplement the funds paid by the Mississippi
47	Fair Commission for livestock premiums at the State Fair, all
48	livestock premiums to be paid on the American system of judging
49	(1st, 2nd, 3rd, 4th, etc.) on all classes entered in the senior
50	division for the fiscal year beginning July 1, 2007, and ending
51	June 30, 2008\$ 26,997.00.
52	(c) For the county livestock shows in offering and
53	paying prizes or awards to competitors in the approved county
54	livestock shows of Mississippi, for the fiscal year beginning
55	July 1, 2007, and ending June 30, 2008 \$ 13,138.00.
56	Provided, however, that of the amount herein appropriated in
57	subsection (c), not more than One Thousand Dollars (\$1,000.00)
58	shall be expended or used in any one county of the state during
59	each fiscal year. Provided, further, that none of the monies
60	herein appropriated in subsection (c) shall be used in offering or
61	paying prizes or awards for any livestock show that is not held
62	where there are adequate barns, pens and other facilities

66	association, and such association shall guarantee a minimum amount
67	of Five Hundred Dollars (\$500.00) to be used in the paying of

69	held and premiums paid, fifty percent (50%) of the amount, not
70	exceeding One Thousand Dollars (\$1,000.00), shall be paid upon
71	requisition to the Mississippi Fair Commission.
72	Provided, further, in subsection (c) that in any county which
73	has two (2) shows with proper facilities, and a contiguous county
74	has no such fair and desires to participate in a fair to be held
75	in an adjoining county, each of the two (2) fairs in one (1)
76	county may receive an equal proportion of the funds hereby
77	appropriated, provided, both shows shall not receive an aggregate
78	sum of more than One Thousand Dollars (\$1,000.00).
79	(d) For the purpose of offering awards and prizes to
80	competitors in the five (5) district livestock shows, for the
81	fiscal year beginning July 1, 2007, and ending June 30, 2008
82	\$ 71,344.00.
83	(e) For the purpose of offering awards and prizes to
84	competitors in the five (5) state dairy shows as provided in
85	Section 69-5-101 et seq., Mississippi Code of 1972, for the fiscal
86	year beginning July 1, 2007, and ending June 30, 2008

88	Provided, further, that no part of the money herein
89	appropriated under the provisions of subsections (d) and (e) shall
90	be used for any other purpose than to pay premium awards at said
91	shows and state shows and expositions receiving legislative
92	appropriation shall not conflict in dates in order that livestock
93	exhibitors may make the circuit of shows. Provided, further, that
94	none of the above mentioned funds shall be paid to any district
95	shows unless shows are held prior to roundup.

97 appropriated under the provisions of subsections (d) and (e) shall 98 be used in awarding prizes or premiums to 4-H Club members and 99 Smith-Hughes School members and other boys and girls having 100 entries in said shows. 101 All funds herein appropriated under the provisions of subsections (d) and (e) for the five (5) district livestock shows 102 and the five (5) fall state dairy shows shall be distributed in 103 104 such manner that the livestock exhibitors will each draw equal 105 premium awards for comparable grades and placings at each of the 106 said five (5) district spring shows and the five (5) fall state shows. The management of each district spring show and each state 107 108 fall show shall submit to the Mississippi Fair Commission, within 109 fifteen (15) days after the close of each said show, a full report on the number of exhibitors at each said show, with the grades and 110 111 placings of the different classes of livestock exhibited. 112 The Executive Secretary of the Mississippi Fair Commission, together with a committee of three (3) to be named by the 113 114 President of the Mississippi Livestock Council from that 115 organization, shall summarize and prepare a unified list of awards 116 for like classes in all spring district livestock shows and fall 117 state dairy shows receiving state premium money, as authorized in 118 subsections (d) and (e).
