1 2 3	A CONCURRENT RESOLUTION TO CREATE A STUDY COMMITTEE TO STUDY THE TAX SYSTEM OF THIS STATE AND TO MAKE RECOMMENDATIONS THEREON TO THE LEGISLATURE; AND FOR RELATED PURPOSES.
4	NOW, THEREFORE, BE IT RESOLVED BY THE MISSISSIPPI STATE
5	SENATE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That:
6	(1) There is hereby created a study committee on the tax
7	system of Mississippi. The committee shall make a report of its
8	findings and recommendations to the Legislature during the 2008
9	Regular Session, including any recommended legislation.
10	(2) The committee shall be composed of the following
11	members:
12	(a) The President Pro Tempore of the Mississippi
13	Senate;
14	(b) The Speaker Pro Tempore of the Mississippi House of
15	Representatives;
16	(c) The Chairman of the Senate Appropriations
17	Committee;
18	(d) The Chairman of the House Appropriations Committee;
19	(e) The Chairman of the Senate Finance Committee;
20	(f) The Chairman of the House Ways and Means Committee;
21	(g) The State Treasurer, or his designee;
22	(h) The Executive Director of the Department of Finance
23	and Administration;
24	(i) The State Auditor, or his designee;
25	(j) One (1) member designated by the State Tax

- 27 (k) One (1) member designated by the State Board of
- 28 Public Accountancy;
- 29 (1) One (1) member designated by the President of The
- 30 Mississippi Bar from the Taxation Section of The Mississippi Bar;
- 31 (m) One (1) member designated by the Mississippi
- 32 Supervisors Association;
- 33 (n) One (1) member designated by the Mississippi
- 34 Municipal Association; and
- 35 (o) Three (3) representatives of the general public,
- 36 one (1) designated by the Governor, one (1) by the Lieutenant
- 37 Governor and one (1) by the Speaker of the House of
- 38 Representatives.
- 39 Appointments shall be made within thirty (30) days after the
- 40 adoption of this resolution by the Legislature, and, within
- 41 fifteen (15) days thereafter on a day to be designated jointly by
- 42 the Lieutenant Governor and the Speaker of the House, the
- 43 committee shall meet and organize by selecting from its membership
- 44 a chairman and a vice chairman. The vice chairman shall also
- 45 serve as secretary and shall be responsible for keeping all
- 46 records of the committee. A majority of the members of the
- 47 committee shall constitute a quorum. In the selection of its
- 48 officers and the adoption of rules, resolutions and reports, an
- 49 affirmative vote of a majority of the committee shall be required.
- 50 All members shall be notified in writing of all meetings, such
- 51 notices to be mailed at least five (5) days prior to the date on
- 52 which a meeting is to be held.
- 53 (3) The committee shall study and make recommendations with
- 54 respect to the imposition of state taxes and the granting of tax
- 55 exemptions in all areas of taxation, including, but not limited
- 56 to, sales taxes, income taxes, privilege taxes, fuel taxes,
- 57 diversions of taxes and the relationship between state and local
- 58 taxes.

- 59 (4) Members of the committee who are not legislators, state
- 60 officials or state employees shall be compensated at the per diem
- 61 rate authorized by Section 25-3-69, Mississippi Code of 1972, and
- 62 shall be reimbursed in accordance with Section 25-3-41,
- 63 Mississippi Code of 1972, for mileage and actual expenses incurred
- 64 in the performance of their duties. Legislative members of the
- 65 committee shall be paid from the contingent expense funds of their
- 66 respective houses in the same manner as provided for committee
- 67 meetings when the Legislature is not in session; however, no per
- 68 diem or expense for attending meetings of the committee will be
- 69 paid while the Legislature is in session. No committee member may
- 70 incur per diem, travel or other expenses unless previously
- 71 authorized by vote, at a meeting of the committee, which action
- 72 shall be recorded in the official minutes of the meeting.
- 73 Nonlegislative members shall be paid from any funds made available
- 74 to the committee for that purpose.
- 75 (5) The committee shall utilize clerical and legal staff
- 76 already employed by the Legislature and any other staff assistance
- 77 made available to it. To effectuate the purpose of this
- 78 resolution, any department, division, board, bureau, commission or
- 79 agency of the state or of any political subdivision thereof shall,
- 80 at the request of the chairman of the committee, provide to the
- 81 committee such facilities, assistance and data as will enable the
- 82 committee properly to carry out its task.
- 83 (6) Upon presentation of its report to the 2008 Regular
- 84 Session, the committee shall be dissolved.
