1 2 3	A CONCURRENT RESOLUTION TO COMMEND THE STAFF MEMBERS OF THE MISSISSIPPI RURAL WATER ASSOCIATION FOR THEIR OUTSTANDING RESPONSE TO HURRICANE KATRINA.
4	WHEREAS, the Mississippi Rural Water Association is a
5	nonprofit organization established in 1978 to aid small towns and
6	rural community water and wastewater systems through training and
7	on-site technical assistance, and their assistance is geared
8	toward the management, operation and maintenance of water and
9	wastewater systems and to aid them in understanding the rules and
10	regulations regarding such operation; and
11	WHEREAS, for years, the Mississippi Rural Water Association
12	has provided water and wastewater training and technical
13	assistance to the small towns and rural communities in all 82
14	Mississippi counties; and
15	WHEREAS, the Mississippi Rural Water Association promotes
16	water conservation and protection through public awareness
17	campaigns and technical assistance activities, and they produce
18	and mail thousands of information pieces each year to keep
19	industry and government leaders up-to-date on issues important to
20	the rural water and wastewater industries, thus aiding in the
21	development of effective regulations; and
22	WHEREAS, the Mississippi Rural Water Association has
23	contracts through the National Rural Water Association,
24	Mississippi State Department of Health, Mississippi State
25	Revolving Fund and South Eastern Technical Assistance Center; and
26	WHEREAS, during Hurricane Katrina, the Mississippi Rural
27	Water Association's staff collectively worked many thousands of

28	hours assisting water and wastewater systems to return them to
29	working condition in order for the citizens of Mississippi to have
30	potable drinking water and wastewater; and
31	WHEREAS, the staff of the Mississippi Rural Water Association
32	is still providing water and wastewater technical assistance to
33	systems affected by Hurricane Katrina; and
34	WHEREAS, the Mississippi Rural Water Association won the
35	prestigious Platinum Pump for Excellence in Rural Water Response
36	at the National Rural Water Association's Annual Tribute to
37	Excellence Awards Ceremony held in Dallas, Texas, for their
38	efforts following Hurricane Katrina; and
39	WHEREAS, the Mississippi Legislature and the citizens of
40	Mississippi will never forget the immediate response and continued
41	dedication by the staff of the Mississippi Rural Water Association
42	following this great disaster which befell our state, and these
43	extraordinary individuals merit a special measure of commendation
44	for their commitment to the people of Mississippi in our time of
45	need:

47	MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
