4	WHEREAS, 74% of Americans say that addiction to alcohol has
5	had some impact on them at some point in their lives, whether it
6	was their own personal addiction, that of a friend or family
7	member, or any other experience with addiction. A 63% majority of
8	Americans also say that addiction to either drugs or alcohol has
9	had a great impact on their lives; and
10	WHEREAS, Recovery Month is sponsored by the Substance Abuse
11	and Mental Health Services Administration's (SAMHSA's) Center for
12	Substance Abuse Treatment (CSAT). CSAT, created in October 1992
13	by a Congressional mandate, provides national leadership in the
14	Federal government's effort to improve the lives of individuals
15	and their families affected by alcohol and drug abuse. CSAT works
16	to improve access to clinically sound, cost-effective addiction
17	treatment to reduce the health and social cost to our communities
18	and the nation. Such factors as inadequate capacity, limited
19	public and private health insurance benefits and stigma have
20	contributed to the gap between the number of people who need
21	treatment and the number who receive it; and
22	WHEREAS, Recovery Month is an annual observance that takes
23	place during the month of September. The Recovery Month
24	observance highlights the societal benefits of substance abuse
25	treatment, lauds the contributions of treatment providers and
26	promotes the message that recovery from substance abuse in all its

forms is possible. The observance also encourages citizens to
