REPORT OF CONFERENCE COMMITTEE

MR. SPEAKER AND MADAM PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1675: Appropriation; Public Utilities Staff.

We, therefore, respectfully submit the following report and recommendation:

1. That the Senate recede from its Amendment No. 1.

2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be

Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to the realignment component of the Variable Compensation Plan or One Thousand Five Hundred Dollars (\$1,500.00), whichever is greater, to be awarded on July 1, 2007.

38 With the funds herein appropriated, it is the intention of 39 the Legislature that it shall be the agency's responsibility to make certain that funds required to be appropriated for "Personal 40 Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008 41 42 funds appropriated for that purpose, unless programs or positions 43 are added to the agency's Fiscal Year 2008 budget by the 44 Mississippi Legislature. Based on data provided by the 45 Legislative Budget Office, the State Personnel Board shall 46 determine and publish the projected annual cost to fully fund all 47 appropriated positions in compliance with the provisions of this 48 act. It shall be the responsibility of the agency head to insure 49 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2008 appropriations for "Personal 50 51 Services" when annualized, with the exception of escalated funds and educational benchmarks. If, at the time the agency takes any 52 action to change "Personal Services", the State Personnel Board 53 determines that the agency has taken an action which would cause 54 the agency to exceed this projected annual cost or the Fiscal Year 55 56 2008 "Personal Services" appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or 57 58 the appropriation requirement will be processed by the State

On January 1, 2008, the State Personnel Board 61 will make adjustments to the structure side of the compliance 62 report based on data provided by the Legislative Budget Office in 63 order for agencies to award educational benchmarks.

64 Any transfers or escalations shall be made in accordance with 65 the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State 66 Personnel Board shall not escalate positions without written 67 68 approval from the Department of Finance and Administration. The 69 Department of Finance and Administration shall not provide written 70 approval to escalate any funds for salaries and/or positions 71 without proof of availability of new or additional funds above the 72 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

77 SECTION 3. It is the intention of the Legislature that the 78 Public Utilities Staff shall maintain complete accounting and 79 personnel records related to the expenditure of all funds appropriated under this act and that such records shall be in the 80 81 same format and level of detail as maintained for Fiscal Year 2007. It is further the intention of the Legislature that the 82 83 agency's budget request for Fiscal Year 2009 shall be submitted to the Joint Legislative Budget Committee in a format and level of 84 85 detail comparable to the format and level of detail provided during the Fiscal Year 2008 budget request process. 86

87 **SECTION 4.** It is the intention of the Legislature that 88 whenever two (2) or more bids are received by this agency for the 89 purchase of commodities or equipment, and whenever all things 90 stated in such received bids are equal with respect to price,

A similar preference shall be given to 93 the Mississippi Industries for the Blind whenever purchases are 94 made without competitive bids.

95 SECTION 5. The money herein appropriated shall be paid by 96 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 97 warrants issued by the State Fiscal Officer; and the State Fiscal 98 Officer shall issue his warrants upon requisitions signed by the 99 100 proper person, officer or officers in the manner provided by law. 101 SECTION 6. This act shall take effect and be in force from 102 and after July 1, 2007.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
