## **REPORT OF CONFERENCE COMMITTEE**

## MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 2496: Appropriation; Mississippi Department of Health; Additional FY2007.

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.

2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

11	SECTION 1. In addition to all other sums heretofore

75 SECTION 9. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be 76 77 necessary, is hereby appropriated out of any money in the State 78 Treasury to the credit of the Mississippi Supreme Court which is 79 comprised of special source funds collected by, or otherwise available to, the Court for the purpose of providing appropriation 80 81 authority for the Administrative Office of Courts to fund local 82 personnel salary increases for the fiscal year ending 200,000.00. 83 June 30, 2007.....\$

**SECTION 10.** The money herein appropriated shall be paid by the State Treasurer out of any money in the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law.

90 **SECTION 11.** This act shall take effect and be in force from 91 and after its passage.
