



27 Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008  
28 funds appropriated for that purpose, unless programs or positions  
29 are added to the agency's Fiscal Year 2008 budget by the  
30 Mississippi Legislature. Based on data provided by the  
31 Legislative Budget Office, the State Personnel Board shall  
32 determine and publish the projected annual cost to fully fund all  
33 appropriated positions in compliance with the provisions of this  
34 act. It shall be the responsibility of the agency head to insure  
35 that no single personnel action increases this projected annual  
36 cost and/or the Fiscal Year 2008 appropriations for "Personal  
37 Services" when annualized, with the exception of escalated funds  
38 and educational benchmarks. If, at the time the agency takes any  
39 action to change "Personal Services", the State Personnel Board  
40 determines that the agency has taken an action which would cause  
41 the agency to exceed this projected annual cost or the Fiscal Year  
42 2008 "Personal Services" appropriated level, when annualized, then  
43 only those actions which reduce the projected annual cost and/or  
44 the appropriation requirement will be processed by the State  
45 Personnel Board until such time as the requirements of this  
46 provision are met. On January 1, 2008, the State Personnel Board  
47 will make adjustments to the structure side of the compliance  
48 report based on data provided by the Legislative Budget Office in  
49 order for agencies to award educational benchmarks.

50 Any transfers or escalations shall be made in accordance with  
51 the terms, conditions and procedures established by law or  
52 allowable under the terms set forth within this act. The State  
53 Personnel Board shall not escalate positions without written  
54 approval from the Department of Finance and Administration. The  
55 Department of Finance and Administration shall not provide written  
56 approval to escalate any funds for salaries and/or positions  
57 without proof of availability of new or additional funds above the  
58 appropriated level.

59 No general funds authorized to be expended herein shall be  
60 used to replace federal funds and/or other special funds which are  
61 being used for salaries authorized under the provisions of this  
62 act and which are withdrawn and no longer available.

63 **SECTION 3.** It is the intention of the Legislature that the  
64 Board of Architecture shall maintain complete accounting and  
65 personnel records related to the expenditure of all funds  
66 appropriated under this act and that such records shall be in the  
67 same format and level of detail as maintained for Fiscal Year  
68 2007. It is further the intention of the Legislature that the  
69 agency's budget request for Fiscal Year 2009 shall be submitted to  
70 the Joint Legislative Budget Committee in a format and level of  
71 detail comparable to the format and level of detail provided  
72 during the Fiscal Year 2008 budget request process.

73 **SECTION 4.** It is the intention of the Legislature that  
74 whenever two (2) or more bids are received by this agency for the  
75 purchase of commodities or equipment, and whenever all things  
76 stated in such received bids are equal with respect to price,  
77 quality and service, the Mississippi Industries for the Blind  
78 shall be given preference. A similar preference shall be given to  
79 the Mississippi Industries for the Blind whenever purchases are  
80 made without competitive bids.

81 **SECTION 5.** The money herein appropriated shall be paid by  
82 the State Treasurer out of any money in the State Treasury to the  
83 credit of the proper fund or funds as set forth in this act, upon  
84 warrants issued by the State Fiscal Officer; and the State Fiscal  
85 Officer shall issue his warrants upon requisitions signed by the  
86 proper person, officer or officers in the manner provided by law.

87 **SECTION 6.** This act shall take effect and be in force from  
88 and after July 1, 2007.
