

House Amendments to Senate Bill No. 2495

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

14 **SECTION 1.** In addition to all other sums heretofore
15 appropriated, the following sum, or so much thereof as may be
16 necessary, is hereby appropriated out of any money in the State
17 Treasury to the credit of the Mississippi Insurance Department
18 which is comprised of special source funds collected by, or
19 otherwise available to, the Department for the purpose of funding
20 the Mississippi Residential Electronic Protection Licensing
21 Advisory Act as established in Senate Bill 2742, 2006 Regular
22 Session, for the fiscal year ending June 30, 2007.....
23 \$ 265,222.00.

24 Of the funds provided under the provisions of this section,
25 an amount not to exceed One Hundred Twenty-seven Thousand Seven
26 Hundred Sixty-eight Dollars (\$127,768.00) shall be expended for a
27 Deputy Fire Marshall Supervisor, Deputy Fire Marshall I and an
28 Administrative Assistant IV.

29 **SECTION 2.** In addition to all other sums heretofore
30 appropriated, the following sum, or so much thereof as may be
31 necessary, is appropriated out of any funds in the State Treasury
32 to the credit of the State Board of Dental Examiners, which is
33 comprised of any special funds collected by or otherwise available
34 to the board for the purpose of defraying the expenses of the
35 board, for the fiscal year ending June 30, 2007.....
36 \$ 42,000.00.

37 **SECTION 3.** In addition to all other sums heretofore
38 appropriated, the following sum, or so much thereof as may be
39 necessary, is appropriated out of any money in the State General

40 Fund, not otherwise appropriated, for the purpose of paying
41 salaries and travel expenses of district attorneys and assistant
42 district attorneys of the state for the fiscal year ending
43 June 30, 2007..... \$ 110,000.00.

44 **SECTION 4.** In addition to all other sums heretofore
45 appropriated, the following sum, or so much thereof as may be
46 necessary, is hereby appropriated out of any money in the State
47 General Fund not otherwise appropriated to the Department of
48 Public Safety for the purpose of defraying the expenses of the
49 Department for the period beginning upon passage and through the
50 fiscal year ending June 30, 2008..... \$ 1,200,000.00.

51 **SECTION 5.** In addition to all other sums heretofore
52 appropriated, the following sum, or so much thereof as may be
53 necessary, is hereby appropriated out of any money in the State
54 General Fund not otherwise appropriated to the State Tax
55 Commission for the purpose of defraying the expense of replacing
56 the roof at the Liquor Distribution Center for the period
57 beginning upon passage and through the fiscal year ending June 30,
58 2008..... \$ 500,000.00.

59 **SECTION 6.** In addition to all other sums heretofore
60 appropriated, the following sum, or so much thereof as may be
61 necessary, is hereby appropriated out of any money in the State
62 General Fund not otherwise appropriated for the purpose of paying
63 for certain outside legal assistance, expert witness fees, court
64 fees, judgments and settlement agreements incurred by the Office
65 of the Attorney General for the fiscal year ending
66 June 30, 2007..... \$ 1,822,861.00.

87 **SECTION 7.** The money herein appropriated shall be paid by
88 the State Treasurer out of any money in the proper fund or funds
89 as set forth in this act, upon warrants issued by the State Fiscal
90 Officer; and the State Fiscal Officer shall issue his warrants
91 upon requisitions signed by the proper person, officer or officers
92 in the manner provided by law.

93 **SECTION 8.** This act shall take effect and be in force from
94 and after its passage.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF SPECIAL FUNDS TO
2 DEFRAY THE EXPENSES OF THE ELECTRONIC PROTECTION LICENSING
3 ADVISORY ACT FOR FISCAL YEAR 2007; TO DEFRAY THE EXPENSES OF THE
4 STATE BOARD OF DENTAL EXAMINERS FOR FISCAL YEAR 2007; AN
5 ADDITIONAL APPROPRIATION OF STATE GENERAL FUNDS TO DEFRAY THE
6 EXPENSES OF THE DISTRICT ATTORNEYS AND ASSISTANT DISTRICT
7 ATTORNEYS FOR FISCAL YEAR 2007; TO DEFRAY THE EXPENSES OF THE
8 DEPARTMENT OF PUBLIC SAFETY FOR FISCAL YEARS 2007 AND 2008; TO
9 DEFRAY THE EXPENSES OF THE STATE TAX COMMISSION FOR FISCAL YEARS
10 2007 AND 2008; AND TO DEFRAY THE EXPENSES OF THE OFFICE OF THE
11 ATTORNEY GENERAL FOR CERTAIN LEGAL EXPENSES, JUDGMENTS AND
12 SETTLEMENTS FOR FISCAL YEAR 2007.
