- 32 (m) The Chairman of the House Appropriations Committee,
- 33 or his designee.
- 34 (2) At its first meeting, the task force shall elect a
- 35 chairman and vice chairman from its membership and shall adopt

- 37 of the task force shall receive a per diem in the amount provided
- 38 in Section 25-3-69 for each day engaged in the business of the
- 39 task force. Members of the task force other than the legislative
