Senate Amendments to House Bill No. 1231

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6 Section 63-11-30, Mississippi Code of 1972, is 7 amended as follows: 63-11-30. (1) It is unlawful for any person to drive or 8 otherwise operate a vehicle within this state who (a) is under the 9 10 influence of intoxicating liquor; (b) is under the influence of any other substance which has impaired such person's ability to 11 operate a motor vehicle; (c) has an alcohol concentration of eight 12 13 one-hundredths percent (.08%) or more for persons who are above 14 the legal age to purchase alcoholic beverages under state law, or 15 two one-hundredths percent (.02%) or more for persons who are below the legal age to purchase alcoholic beverages under state 16 17 law, in the person's blood based upon grams of alcohol per one hundred (100) milliliters of blood or grams of alcohol per two 18 19 hundred ten (210) liters of breath as shown by a chemical analysis of such person's breath, blood or urine administered as authorized 2.0 by this chapter; (d) is under the influence of any drug or 2.1 22 controlled substance, the possession of which is unlawful under the Mississippi Controlled Substances Law; or (e) has an alcohol 23 24 concentration of four one-hundredths percent (.04%) or more in the person's blood, based upon grams of alcohol per one hundred (100) 25 26 milliliters of blood or grams of alcohol per two hundred ten (210) 27 liters of breath as shown by a chemical analysis of such person's blood, breath or urine, administered as authorized by this chapter 28 29 for persons operating a commercial motor vehicle. 30 Except as otherwise provided in subsection (3),

upon conviction of any person for the first offense of violating

32 subsection (1) of this section where chemical tests provided for 33 under Section 63-11-5 were given, or where chemical test results are not available, such person shall be fined not less than Two 34 35 Hundred Fifty Dollars (\$250.00) nor more than One Thousand Dollars 36 (\$1,000.00), or imprisoned for not more than forty-eight (48) hours in jail or both; and the court shall order such person to 37 attend and complete an alcohol safety education program as 38 39 provided in Section 63-11-32. The court may substitute attendance at a victim impact panel instead of forty-eight (48) hours in 40 41 In addition, the Department of Public Safety, the Commissioner of Public Safety or his duly authorized agent shall, 42 after conviction and upon receipt of the court abstract, suspend 43 the driver's license and driving privileges of such person for a 44 period of not less than ninety (90) days and until such person 45 attends and successfully completes an alcohol safety education 46 program as herein provided * * *. Commercial driving privileges 47 shall be suspended as provided in Section 63-1-83. 48 The circuit court having jurisdiction in the county in which 49 50 the conviction was had or the circuit court of the person's county of residence may reduce the suspension of driving privileges under 51 52 Section 63-11-30(2)(a) if the denial of which would constitute a hardship on the offender, except that no court may issue such an 53 54 order reducing the suspension of driving privileges under this subsection until thirty (30) days have elapsed from the effective 55 date of the suspension. Hardships shall only apply to first 56 offenses under Section 63-11-30(1), and shall not apply to second, 57 58 third or subsequent convictions of any person violating subsection 59 (1) of this section. A reduction of suspension on the basis of hardship shall not be available to any person who refused to 60 61 submit to a chemical test upon the request of a law enforcement 62 officer as provided in Section 63-11-5. When the petition is filed, such person shall pay to the circuit clerk of the court 63 where the petition is filed a fee of Fifty Dollars (\$50.00), which 64 65 shall be deposited into the State General Fund to the credit of a special fund hereby created in the State Treasury to be used for 66

67 alcohol or drug abuse treatment and education, upon appropriation

68 by the Legislature. This fee shall be in addition to any other

- 69 court costs or fees required for the filing of petitions.
- 70 The petition filed under the provisions of this subsection

- 78 The order entered under the provisions of this subsection

- 82 63-11-32. A certified copy of such order shall be delivered to

- 86 petitioner, including, but not limited to, the name, mailing
- 87 address, street address, social security number and driver's

- At any time following at least thirty (30) days of suspension
- 90 for a first offense violation of this section, the court may grant
- 91 the person hardship driving privileges upon written petition of
- 92 the defendant, if it finds reasonable cause to believe that
- 93 revocation would hinder the person's ability to:
- 94 (i) Continue his employment;
- 95 (ii) Continue attending school or an educational
- 96 institution; or
- 97 (iii) Obtain necessary medical care.
- 98 Proof of the hardship shall be established by clear and
- 99 convincing evidence which shall be supported by independent
- 100 documentation.

101 Except as otherwise provided in subsection (3), 102 upon any second conviction of any person violating subsection (1) of this section, the offenses being committed within a period of 103 104 five (5) years, such person shall be fined not less than Six Hundred Dollars (\$600.00) nor more than One Thousand Five Hundred 105 Dollars (\$1,500.00), shall be imprisoned not less than five (5) 106 107 days nor more than one (1) year and sentenced to community service 108 work for not less than ten (10) days nor more than one (1) year. 109 The minimum penalties shall not be suspended or reduced by the court and no prosecutor shall offer any suspension or sentence 110 reduction as part of a plea bargain. Except as may otherwise be 111 provided by paragraph (d) of this subsection, the Commissioner of 112 113 Public Safety shall suspend the driver's license of such person 114 for two (2) years. Suspension of a commercial driver's license 115 shall be governed by Section 63-1-83. Upon any second conviction as described in this paragraph, the court shall ascertain whether 116 117 the defendant is married, and if the defendant is married shall obtain the name and address of the defendant's spouse; the clerk 118 119 of the court shall submit this information to the Department of 120 Public Safety. Further, the commissioner shall notify in writing, 121 by certified mail, return receipt requested, the owner of the 122 vehicle and the spouse, if any, of the person convicted of the 123 second violation of the possibility of forfeiture of the vehicle 124 if such person is convicted of a third violation of subsection (1) of this section. The owner of the vehicle and the spouse shall be 125 126 considered notified under this paragraph if the notice is deposited in the United States mail and any claim that the notice 127 128 was not in fact received by the addressee shall not affect a 129 subsequent forfeiture proceeding. 130 For any second or subsequent conviction of any person under 131 this section, the person shall also be subject to the penalties set forth in Section 63-11-31. 132

(d) Except as otherwise provided in subsection (3), any person convicted of a second violation of subsection (1) of this section shall receive an in-depth diagnostic assessment, and if as a result of such assessment is determined to be in need of treatment of his alcohol and/or drug abuse problem, such person shall successfully complete treatment of his alcohol and/or drug abuse problem at a program site certified by the Department of Mental Health. Such person shall be eligible for reinstatement of his driving privileges upon the successful completion of such treatment after a period of one (1) year after such person's driver's license is suspended. Each person who receives a diagnostic assessment shall pay a fee representing the cost of such assessment. Each person who participates in a treatment program shall pay a fee representing the cost of such treatment.

- (g) The court shall have the discretion to rule that a 294 295 first offense of this subsection by a person under the age of 296 twenty-one (21) years shall be nonadjudicated. Such person shall 297 be eligible for nonadjudication only once. The Department of Public Safety shall maintain a confidential registry of all cases 298 299 which are nonadjudicated as provided in this paragraph. A judge 300 who rules that a case is nonadjudicated shall forward such ruling 301 to the Department of Public Safety. Judges and prosecutors 302 involved in implied consent violations shall have access to the 303 confidential registry for the purpose of determining 304 nonadjudication eligibility. A record of a person who has been 305 nonadjudicated shall be maintained for five (5) years or until 306 such person reaches the age of twenty-one (21) years. Any person 307 whose confidential record has been disclosed in violation of this paragraph shall have a civil cause of action against the person 308 309 and/or agency responsible for such disclosure.

The Commissioner of Public Safety or his authorized agent 317 318 shall suspend the driver's license or permit to drive or deny the issuance of a license or permit to such person as provided for 319 320 first, second and third or subsequent offenders in subsection (2) 321 of this section. Such suspension shall be in addition to any 322 suspension imposed pursuant to subsection (1) of Section 63-11-23. 323 The minimum suspension imposed under this subsection shall not be 324 reduced and no prosecutor is authorized to offer a reduction of 325 such suspension as part of a plea bargain.

Every person who operates any motor vehicle in violation of the provisions of subsection (1) of this section and who in a negligent manner causes the death of another or mutilates, disfigures, permanently disables or destroys the tongue, eye, lip, nose or any other limb, organ or member of another shall, upon conviction, be guilty of a separate felony for each such death, mutilation, disfigurement or other injury and shall be committed to the custody of the State Department of Corrections for a period of time of not less than five (5) years and not to exceed twenty-five (25) years for each such death, mutilation, disfigurement or other injury, and the imprisonment for the second or each subsequent conviction, in the discretion of the court, shall commence either at the termination of the imprisonment for the preceding conviction or run concurrently with the preceding conviction. Any person charged with causing the death of another as described in this subsection shall be required to post bail before being released after arrest.

the traffic ticket, citation or affidavit stating that the person 345 346 arrested either employed an attorney or waived his right to an attorney after having been properly advised. If the person 347 348 arrested employed an attorney, the name, address and telephone number of the attorney shall be written on the ticket, citation or 349 350 affidavit. The judge shall cause a copy of the traffic ticket, citation or affidavit, and any other pertinent documents 351 concerning the conviction, to be sent to the Commissioner of 352 353 Public Safety. - 359 Convictions in other states of violations for driving or operating a vehicle while under the influence of an intoxicating 360 361 liquor or while under the influence of any other substance that 362 has impaired the person's ability to operate a motor vehicle occurring after July 1, 1992, shall be counted for the purposes of 363 364 determining if a violation of subsection (1) of this section is a 365 first, second, third or subsequent offense and the penalty that 366 shall be imposed upon conviction for a violation of subsection (1) of this section. 367
- 368 (8) For the purposes of determining how to impose the 369 sentence for a second, third or subsequent conviction under this 370 section, the indictment shall not be required to enumerate 371 previous convictions. It shall only be necessary that the 372 indictment state the number of times that the defendant has been 373 convicted and sentenced within the past five (5) years under this 374 section to determine if an enhanced penalty shall be imposed. 375 amount of fine and imprisonment imposed in previous convictions 376 shall not be considered in calculating offenses to determine a 377 second, third or subsequent offense of this section.
- 378 (9) Any person under the legal age to obtain a license to 379 operate a motor vehicle convicted under this section shall not be

- 380 eligible to receive such license until the person reaches the age
- 381 of eighteen (18) years.
- 382 (10) Suspension of driving privileges for any person
- 383 convicted of violations of Section 63-11-30(1) shall run
- 384 consecutively.
- 385 (11) The court may order the use of any ignition interlock
- 386 device as provided in Section 63-11-31.
- 387 **SECTION 2.** This act shall take effect and be in force from
- 388 and after July 1, 2007.

- AN ACT TO AMEND SECTION 63-11-30, MISSISSIPPI CODE OF 1972,
- 2 TO REQUIRE COMPLETION OF ALCOHOL SAFETY PROGRAM BEFORE
- 3 REINSTATEMENT OF A DRIVER'S LICENSE SUBSEQUENT TO CONVICTION OF
- DRIVING UNDER THE INFLUENCE OF ALCOHOL; AND FOR RELATED PURPOSES.
