Senate Amendments to House Bill No. 1656

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to the realignment component of the Variable Compensation Plan or One Thousand Dollars (\$1,000.00), or Three Percent (3%) whichever is greater, to be awarded on July 1, 2007.

38 With the funds herein appropriated, it is the intention of 39 the Legislature that it shall be the agency's responsibility to make certain that funds required to be appropriated for "Personal 40 41 Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008 42 funds appropriated for that purpose, unless programs or positions 43 are added to the agency's Fiscal Year 2009 budget by the Mississippi Legislature. Based on data provided by the 44 45 Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to fully fund all 46 47 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 48 act. 49 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2008 appropriation for "Personal 50 Services" when annualized, with the exception of escalated funds. 51 If, at the time the agency takes any action to change "Personal 52 Services," the State Personnel Board determines that the agency 53 54 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2008 "Personal Services" 55 56 appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation 57 58 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 59

Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written

H. B. 1656 PAGE 2 66 approval to escalate any funds for salaries and/or positions 67 without proof of availability of new or additional funds above the 68 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

73 The agency shall not take any action to promote or otherwise 74 award salary increases through reallocation, reclassification, 75 realignment, education benchmark, career ladder, or any other 76 means to increase salaries of employees or positions unless 77 specifically exempted by the following conditions: the award of 78 teacher pay increases, the advancement of a trainee/cadet to the next level of a bona fide career ladder, the award of an 79 80 educational benchmark for the attainment of Certified Public Accountant License or higher level professional certification as 81 determined by the State Personnel Board, the immediate replacement 82 of a departing employee with an individual from within state 83 84 service or a new hire at a salary level equivalent to that of the 85 departing employee, and the emergency appointment of nurses, 86 pharmacists or other health care professionals at a salary to be 87 determined by the State Personnel Board, unless otherwise authorized in this act. 88

89 SECTION 3. It is the intention of the Legislature that the Mississippi Board of Nursing shall maintain complete accounting 90 91 and personnel records related to the expenditure of all funds 92 appropriated under this act and that such records shall be in the 93 same format and level of detail as maintained for Fiscal Year It is further the intention of the Legislature that the 94 2007. 95 agency's budget request for Fiscal Year 2009 shall be submitted to the Joint Legislative Budget Committee in a format and level of 96 detail comparable to the format and level of detail provided 97 during the Fiscal Year 2008 budget request process. 98

99 SECTION 4. It is the intention of the Legislature that 100 whenever two (2) or more bids are received by this agency for the 101 purchase of commodities or equipment, and whenever all things 102 stated in such received bids are equal with respect to price, 103 quality and service, the Mississippi Industries for the Blind 104 shall be given preference. A similar preference shall be given to 105 the Mississippi Industries for the Blind whenever purchases are 106 made without competitive bids.

107 SECTION 5. The money herein appropriated shall be paid by 108 the State Treasurer out of any money in the State Treasury to the 109 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 110 111 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 112 SECTION 6. This act shall take effect and be in force from 113 and after July 1, 2007. 114
