AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

7	SECTION 1. The following sum, or so much thereof as may be
8	necessary, is hereby reappropriated out of any money in the State
9	General Fund not otherwise appropriated, to the Department of
10	Finance and Administration, acting through the Bureau of Building,
11	Grounds and Real Property Management, for the purpose of
12	reauthorizing the expenditure of State General Funds, as
13	authorized in Senate Bill No. 2005, First Extraordinary Session of
14	2006, for the fiscal year beginning July 1, 2007, and ending June
15	30, 2008\$ 1,219,537.00.
16	This reappropriation is made for the purpose of reauthorizing
17	the expenditure of State General Funds for construction of offices
18	and other necessary renovations at the Walter Sillers Building.
19	Notwithstanding the amount reappropriated under the
20	provisions of this section, in no event shall the amount expended
21	exceed the unexpended balance as of June 30, 2007, or change the
22	purpose for which the funds were originally authorized.
23	SECTION 2. The following sum, or so much thereof as may be
24	necessary, is hereby reappropriated out of any money in the State
25	Treasury to the credit of Fund No. 3931, to the Department of
26	Finance and Administration, acting through the Bureau of Building,
27	Grounds and Real Property Management, for the purpose of
28	reauthorizing the expenditure of funds previously appropriated for
29	construction and/or repair and renovation projects at various
30	state agencies and institutions, as authorized in House Bill No.
31	1607, Regular Session of 2006, for the fiscal year beginning July
32	1, 2007, and ending June 30, 2008

33	\$ 7,061,952.93.
34	This reappropriation is made for the purpose of reauthorizing
35	the expenditure of special funds for construction and/or repair
36	and renovation projects at various state agencies and institutions
37	that had been authorized by the Legislature in prior fiscal years.
38	Notwithstanding the amount reappropriated under the
39	provisions of this section, in no event shall the amount expended
40	exceed the unexpended balance as of June 30, 2007, or change the
41	purpose for which the funds were originally authorized.
42	SECTION 3. The Bureau of Building, Grounds and Real Property
43	Management of the Office of General Services is hereby expressly
44	authorized and empowered to receive, budget and expend any state,
45	local or other source funds designated for supplemental funding of
46	construction and/or repair and renovation projects.
47	SECTION 4. The money herein appropriated shall be paid by
48	the State Treasurer out of any money in the State Treasury to the
49	credit of the proper fund or funds as set forth in this act, upon
