## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

30 (1) The Chairman of the House Judiciary En Banc
31 Committee, or his designee;

32 (m) The Chairman of the House Appropriations Committee,
 33 or his designee.

34 (2) At its first meeting, the task force shall elect a chairman and vice chairman from its membership and shall adopt 35 rules for transacting its business and keeping records. 36 Members of the task force shall receive a per diem in the amount provided 37 in Section 25-3-69 for each day engaged in the business of the 38 39 task force. Members of the task force other than the legislative 40 members shall receive reimbursement for travel expenses incurred 41 while engaged in official business of the task force in accordance with Section 25-3-41 and the legislative members of the task force 42 43 shall receive the expense allowance provided for in Section 44 5-1-47.

(3) The duties of the task force shall be to:

46 (a) Make a comprehensive study of the needs by circuit
47 court districts for state-supported indigent defense counsel <u>to</u>
48 <u>examine</u> existing public defender programs <u>including indigent</u>
49 <u>defense provided in the youth courts</u>. Reports shall be provided
50 to the Legislature each year at least one (1) month before the
51 convening of the regular session.

(b) Examine and study approaches taken by other states
in the implementation and costs of state-supported indigent
criminal <u>and delinquency</u> cases.
