## Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

## House Bill No. 1679

## **BY: Committee**

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

12	SECTION 1. The following sums, or so much thereof as may be
13	necessary, are hereby appropriated out of any money in the State

68	fiscal year beginning July 1, 2007, and ending June 30, 2008, as

72	SECTION 3. The following sum, or so much thereof as may be
73	necessary, is hereby appropriated out of any money in the State

76	beginning July 1, 2007, and ending June 30, 2008

86	SECTION 4. The Legislature shall have the authority to
87	escalate its budget and expend funds from the Legislative
88	Extraordinary Session Expense Revolving Fund, as authorized in
89	Section 5-1-57, Mississippi Code of 1972, in accordance with rules
90	and regulations of the Department of Finance and Administration in
91	a manner consistent with the escalation of federal funds. The
a 2	authority granted in this section is provided for the nurpose of

- 93 paying the expenses of the members of the Legislature incurred
- 94 during any Extraordinary Session of the Legislature occurring
- 95 during the period beginning July 1, 2007, and ending
- 96 June 30, 2008.
- 97 **SECTION 5.** It is the intention of the Legislature that
- 98 whenever two (2) or more bids are received by this Legislature for
- 99 the purchase of commodities or equipment, and whenever all things
- 100 stated in such received bids are equal with respect to price,
- 101 quality and service, the Mississippi Industries for the Blind
- 102 shall be given preference. A similar preference shall be given to
- 103 the Mississippi Industries for the Blind whenever purchases are
- 104 made without competitive bids.
- 105 **SECTION 6.** The money herein appropriated shall be paid by
- 106 the State Treasurer out of any money in the State Treasury to the
- 107 credit of the proper fund or funds as set forth in this act, upon
- 108 warrants issued by the State Fiscal Officer; and the State Fiscal
- 109 Officer shall issue his warrants upon requisitions signed by the
- 110 proper person, officer or officers, in the manner provided by law.
- 111 SECTION 7. This act shall take effect and be in force from
- 112 and after July 1, 2007.
