## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

The following sum, or so much thereof as may be 7 necessary, is hereby appropriated out of any money in the State General Fund not otherwise appropriated, for the purpose of paying 8 9 salaries and travel expenses of district attorneys and assistant 10 district attorneys of the state and paying office expenses of district attorneys for the fiscal year beginning July 1, 2007, and 11 ending June 30, 2008.....\$ 16,177,039.00. 12 SECTION 2. The following sum, or so much thereof as may be 13 14 necessary, is hereby appropriated out of any money in the State Prosecutor Compensation Fund, referred to in Section 99-19-73, 15 Mississippi Code of 1972, for the purpose of paying salaries of 16 17 assistant district attorneys of the state as authorized in Section 25-31-5(1) for the fiscal year beginning July 1, 2007, and ending 18 19 June 30, 2008..... \$ 546,750.00. SECTION 3. The following sum, or so much thereof as may be 20 21 necessary, is appropriated out of any money in Fund No. 3088 in

the State Treasury, for the purpose of defraying the office

Of the funds appropriated herein, not more than 28 the amounts set forth below shall be expended for the respective 29 purposes: 30 (a) Salaries and travel expenses of district attorneys, 31 assistant district attorneys and criminal investigators of the 32 state: 33 Salaries..... \$16,183,433.00 34 Travel Expenses..... 377,505.00 35 Tort Claims Assessment.....\$ 47,074.00 None of the funds authorized in this section shall be used to 36 reimburse district attorneys or their staff for taxable meals 37 incurred within their geographical district. 38 39 (b) Office expenses of district attorneys as authorized 40 by Section 25-31-8, Mississippi Code of 1972..... .....\$ 994,000.00. 41 42 SECTION 5. Of the funds appropriated in Section 1, office 43 expenses and such funds for salaries shall be provided as authorized in Section 25-3-35(6), Mississippi Code of 1972, to 44 45 fund the salary for one (1) full-time legal assistant in the Sixth 46 Circuit Court District as authorized in Section 25-31-5(2)(f), 47 Mississippi Code of 1972. 48 SECTION 6. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 49 50 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 51 52 Officer shall issue his warrants upon requisitions signed by the 53 proper person, officer or officers, in the manner provided by law. SECTION 7. This act shall take effect and be in force from 54 55 and after July 1, 2007.
