

**House Amendments to Senate Bill No. 2004**

**TO THE SECRETARY OF THE SENATE:**

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

**AMENDMENT NO. 1**

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

8           **SECTION 1.** In addition to all other sums heretofore  
9 appropriated, the following sum, or so much thereof as may be  
10 necessary, is hereby appropriated out of any money in the State  
11 Treasury to the credit of the Mississippi Commission on Judicial  
12 Performance, for the purpose of defraying the expenses of said  
13 commission for the fiscal year ending June 30, 2007 .....  
14 .....\$           25,000.00.

15           The additional funds appropriated in this section are  
16 provided for the purpose of funding 2100 hours of unpaid personal  
17 leave of a deceased employee.

18           **SECTION 2.** That the following sums, or so much thereof as  
19 may be necessary, are hereby appropriated out of any money in the  
20 State General Fund not otherwise appropriated, for the purpose of  
21 paying salaries, mileage, insurance, matching funds and the daily  
22 expense allowance of the members of the Legislature for the First  
23 Extraordinary Session of 2007, as follows:

24           For salaries, mileage, insurance,  
25                    matching funds and daily  
26                    expense allowance of members  
27                    of the House of Representatives.....\$           39,680.00.

28           For salaries, mileage, insurance,  
29                    matching funds and daily  
30                    expense allowance of members  
31                    of the Senate.....\$           15,546.00.

32           **SECTION 3.** In addition to all other sums heretofore  
33 appropriated, the following sum, or so much of it as may be

34 necessary, is appropriated out of any money in the State General  
35 Fund not otherwise appropriated, for the purpose of constructing  
36 the Mississippi Burn Center at the University of Mississippi  
37 Medical Center.....\$ 10,000,000.00.

38 The appropriation in this section is conditional upon any  
39 future employee of the Commission on Judicial Performance, any  
40 other state agency or any citizen of this state being burned by  
41 fire or chemicals and needing the services of a burn center.

42 **SECTION 4.** The money herein appropriated shall be paid by  
43 the State Treasurer out of any money in the proper fund or funds  
44 as set forth in this act, upon warrants issued by the State Fiscal  
45 Officer; and the State Fiscal Officer shall issue his warrants  
46 upon requisitions signed by the proper person, officer or officers  
47 in the manner provided by law.

48 **SECTION 5.** This act shall take effect and be in force from  
49 and after its passage.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF SPECIAL FUNDS  
2 FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI  
3 COMMISSION ON JUDICIAL PERFORMANCE FOR FISCAL YEAR 2007 AND FOR  
4 THE EXPENSES OF THE LEGISLATURE FOR THE FIRST EXTRAORDINARY  
5 SESSION OF 2007 AND FOR MAKING AN ADDITIONAL APPROPRIATION FOR THE  
6 CONSTRUCTION OF THE MISSISSIPPI BURN CENTER.
