SENATE BILL NO. 2581

- AN ACT TO AMEND SECTION 41-111-1, MISSISSIPPI CODE OF 1972,
- 2 TO EXTEND THE DATE OF THE REPEALER ON THE CHILD DEATH REVIEW
- 3 PANEL; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 41-111-1, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 41-111-1. (1) There is created the Child Death Review
- 8 Panel, whose primary purpose is to foster the reduction of infant
- 9 and child mortality and morbidity in Mississippi and to improve
- 10 the health status of infants and children.
- 11 (2) The Child Death Review Panel shall be composed of
- 12 fifteen (15) voting members: the State Medical Examiner or his
- 13 representative, a pathologist on staff at the University of
- 14 Mississippi Medical Center, an appointee of the Lieutenant
- 15 Governor, an appointee of the Speaker of the House of
- 16 Representatives, and one (1) representative from each of the
- 17 following: the State Coroners Association, the Mississippi
- 18 Chapter of the American Academy of Pediatrics, the Office of Vital
- 19 Statistics in the State Department of Health, the Attorney
- 20 General's Office, the State Sheriffs' Association, the Mississippi
- 21 Police Chiefs Association, the Department of Human Services, the
- 22 Children's Advocacy Center, the State Chapter of the March of
- 23 Dimes, the State SIDS Alliance, and Compassionate Friends.
- 24 (3) The Chairman of the Child Death Review Panel shall be
- 25 elected annually by the Review Panel membership. The Review Panel
- 26 shall develop and implement such procedures and policies necessary
- 27 for its operation, including obtaining and protecting confidential

- 28 records from the agencies and officials specified in subsection
- 29 (4) of this section. The Review Panel shall be assigned to the
- 30 State Department of Health for administrative purposes only, and
- 31 the department shall designate staff to assist the Review Panel.
- 32 (4) The Child Death Review Panel shall submit a report
- 33 annually to the Chairmen of the House Public Health and Human
- 34 Services Committee and the Senate Public Health and Welfare
- 35 Committee on or before December 1. The report shall include the
- 36 numbers, causes and relevant demographic information on child and
- 37 infant deaths in Mississippi, and appropriate recommendations to
- 38 the Legislature on how to most effectively direct state resources
- 39 to decrease infant and child deaths in Mississippi. Data for the
- 40 Review Panel's review and reporting shall be provided to the
- 41 Review Panel, upon the request of the Review Panel, by the State
- 42 Medical Examiner's Office, State Department of Health, Department
- 43 of Human Services, medical examiners, coroners, health care
- 44 providers, law enforcement agencies, any other agencies or
- 45 officials having information that is necessary for the Review
- 46 Panel to carry out its duties under this section. The State
- 47 Department of Health shall also be responsible for printing and
- 48 distributing the annual report(s) on child and infant deaths in
- 49 Mississippi.
- 50 (5) This section shall stand repealed on July 1, 2013.
- 51 **SECTION 2.** This act shall take effect and be in force from
- 52 and after July 1, 2010.
