Senate Concurrent Resolution No. 692

BY: Representative Reynolds

1 **AMEND** on line 4 by deleting the words, "NOW, THEREFORE," and
2 inserting in lieu thereof, "SECTION 1."

3 **AMEND FURTHER** by inserting the following after line 10:

4 "SECTION 2. BE IT RESOLVED BY THE LEGISLATURE OF THE STATE
5 OF MISSISSIPPI, That the number of Senators shall be fifty-two
6 (52) and shall be elected from fifty-two (52) districts, composed

505 (a) In any instance in which there is a conflict
506 between the description of a district as set out in Section 2 of
507 this resolution and the map of the Senate Districts developed by

509 conjunction with the adopted redistricting plan, the map shall
510 control; however, in instances in which the map is inconclusive,
511 the criteria set out in paragraphs (b) through (f) shall control
512 the resolution of any dispute or issue regarding the composition
513 of any Senate District;

514 (b) Gaps in the description of any district shall be
515 completed in a manner which results in a total description of that
516 district in a manner which is consonant with the description of
517 adjacent districts and results in complete contiguity of
518 districts;

519 (c) Areas of the state included within the descriptions
520 of more than one (1) district shall be allocated to the district
521 having the lowest population;

522 (d) Areas of the state not included within the
523 descriptions of any district shall be allocated to the adjacent
524 district having the lowest population;

525 (e) In the event that the area subject to corrected
526 description or allocation as provided in paragraphs (b), (c) and
527 (d) of this clause is of such size or contains such population



528 that its inclusion as a unit in any district would result in
529 substantial disparity in the size, shape or population of such
530 district, then the Secretary of State may allocate portions of
531 such area to two (2) or more districts; and

532 (f) In any allocation of area or correction of
533 descriptions made pursuant to this resolution, the Secretary of
534 State shall, consistent with the foregoing standards, preserve the
535 contiguity and compactness of districts and avoid the unnecessary
536 division of political subdivisions.

537 BE IT FURTHER RESOLVED, That copies of such orders shall be
538 filed by the Secretary of State in his own office and in the
539 offices of the affected commissioners of election and registrars.
540 The Secretary of State may adopt reasonable rules regulating the
541 procedure for applications for orders under Section 2 of this
542 resolution in the manner of serving and filing any notice or copy
543 of orders relating thereto. Upon the filing of such an order, the
544 description of any affected district shall be deemed to have been
545 corrected in the manner provided in such order to the full extent
546 as if such correction had been contained in the original
547 description set forth in Section 2 of this resolution.

548 BE IT FURTHER RESOLVED, That the Standing Joint Legislative
549 Committee on Reapportionment is directed to provide all
550 information necessary to assist the counties in identifying the
551 boundaries of the districts described in Section 2 of this

553 BE IT FURTHER RESOLVED, That the redistricting contained in
554 Section 2 of this resolution shall supersede any prior
555 redistricting, and any prior redistricting shall be null and void

558 shall be placed in the editor's notes that follow Section 5-1-3,
559 Mississippi Code of 1972.



560 BE IT FURTHER RESOLVED, That the Chairman of the Senate
561 Elections Committee, with the assistance of counsel employed by
562 the Standing Joint Legislative Committee on Reapportionment, is
563 hereby directed to submit Section 2 of this resolution,
564 immediately upon its adoption by both houses of the Legislature,
565 to the Attorney General of the United States or to the United
566 States District Court for the District of Columbia in accordance
567 with the provisions of the Voting Rights Act of 1965, as amended
568 and extended.

569 BE IT FURTHER RESOLVED, That Section 2 of this resolution
570 shall take effect and be in force from and after the date it is
571 finally effectuated under Section 5 of the Voting Rights Act of
572 1965, as amended and extended, only if a concurrent resolution

575 **SECTION 3.** WHEREAS, it is the responsibility and official
576 mandate of the Legislature to reapportion the state in compliance
577 with the one-person, one-vote requirement of the federal
578 Constitution into election districts as nearly equal as possible
579 according to population and in accordance with other factors
580 heretofore pronounced by the courts; and

1379 Representatives reapportionment map draft, hereinafter referred to
1380 as "the map," prepared by the staff of the Standing Joint
1381 Legislative Committee on Reapportionment, having been duly
1382 examined and approved by resolution duly adopted by the Standing
1383 Joint Legislative Committee on Reapportionment, is hereby
1384 incorporated.

1385 BE IT FURTHER RESOLVED, That "the map" that is developed in
1386 conjunction with the redistricting plan of Section 3 of this
1387 concurrent resolution that is adopted by the Legislature during
1388 the 2011 Regular Session shall control the resolution of any
1389 dispute, if there is a conflict between the language found in the
1390 description of any district and "the map."

1391 BE IT FURTHER RESOLVED, That the Chairman and Vice Chairman
1392 of the Standing Joint Legislative Committee on Reapportionment
1393 shall file with the Secretary of State of Mississippi the Split
1394 Precinct Block List developed in conjunction with the plan that
1395 details the portions of the partial or split precincts that are
1396 contained within a district by census tract and block number, and
1397 such document duly filed with the Secretary of State is hereby
1398 incorporated into and shall be construed to be an integral part of
1399 Section 3 of this joint resolution. Such partial or split
1400 precincts contained in this resolution shall be identifiable by an
1401 asterisk (*) which shall precede its designation within any
1402 electoral district.

1403 BE IT FURTHER RESOLVED, That the map shall be permanently
1404 stored in the Office of the Secretary of State, that one (1) copy
1405 of the computer dataset for the map shall be filed with the Clerk
1406 of the Mississippi House of Representatives and one (1) copy of
1407 such tape shall be stored by the Mississippi Department of
1408 Archives and History. The Secretary of State and the Mississippi
1409 Department of Archives and History are hereby directed to preserve



1410 a copy of the map with the boundaries of the counties' precincts,
1411 as they appear in the Census Bureau's 2010 TIGER line Shape files
1412 released in November 2010, and shall also preserve census tract or
1413 block numbers utilized in splitting any House of Representatives
1414 electoral districts contained in the map. All raw data utilized
1415 in generating any plans in formulating the reapportionment and
1416 redistricting of the Mississippi House of Representatives in
1417 accordance with the map shall also be preserved by the Secretary
1418 of State and the Department of Archives and History.

1419 BE IT FURTHER RESOLVED, That the boundaries of the House of
1420 Representatives districts described above shall be:

1421 (a) The boundaries of the counties as they appear in
1422 the Census Bureau's 2010 TIGER Line Shape files released in
1423 November 2010;

1424 (b) The boundaries of the precincts as such precinct
1425 boundaries are contained in the Census Bureau's 2010 TIGER Line
1426 Shapefiles released in November 2010; and

1427 (c) The boundaries of the census tracts or blocks as
1428 such census tracts or blocks are contained in the Census Bureau's
1429 2010 TIGER Line Shapefiles released in November 2010.

1430 BE IT FURTHER RESOLVED, That the Standing Joint Legislative
1431 Committee on Reapportionment is directed to provide all
1432 information necessary to assist the counties in identifying the
1433 boundaries of the districts described in Section 3 of this
1434 resolution.

1435 BE IT FURTHER RESOLVED, That Section 3 of this resolution
1436 shall be liberally construed to effectuate the purposes hereof and
1437 to redistrict the House of Representatives of this state in
1438 compliance with constitutional requirements.

1439 It is intended that Section 3 of this resolution and the
1440 districts described herein completely encompass all the area
1441 within the state. It is also intended that such districts contain



1442 all the inhabitants in this state. It is further intended that
1443 the redistricting provided for in Section 3 of this resolution
1444 result in the creation of districts which are substantially equal
1445 in population. It is also intended that no district shall include
1446 any of the area included within the description of any other
1447 district.

1448 BE IT FURTHER RESOLVED, That if the districts described in
1449 Section 3 of this resolution do not carry out the purposes hereof
1450 because of: unintentional omissions; duplication; overlapping
1451 areas; erroneous nomenclature; lack of adequate maps or
1452 descriptions of political subdivisions, wards or other divisions
1453 thereof, or of their boundary lines; then the Secretary of State,
1454 at the request of the Standing Joint Legislative Committee on
1455 Reapportionment shall, by order, correct such omissions, overlaps,
1456 erroneous nomenclature or other defects in the description of
1457 districts so as to accomplish the purposes and objectives of this
1458 resolution.

1459 BE IT FURTHER RESOLVED, That copies of such orders shall be
1460 filed by the Secretary of State in his own office and in the
1461 offices of the affected commissioners of election and registrars.
1462 The Secretary of State may adopt reasonable rules regulating the
1463 procedure for applications for orders under Section 3 of this
1464 resolution in the manner of serving and filing any notice or copy
1465 of orders relating thereto. Upon the filing of such an order, the
1466 description of any affected district shall be deemed to have been
1467 corrected in the manner provided in such order to the full extent
1468 as if such correction had been contained in the original
1469 description set forth in Section 3 of this resolution.

1470 BE IT FURTHER RESOLVED, That the redistricting contained in
1471 Section 3 of this resolution shall supersede any prior
1472 redistricting, and any prior redistricting shall be null and void
1473 upon the date Section 3 of this resolution is effectuated pursuant



1474 to the provisions of Section 5 of the Voting Rights Act of 1965,
1475 as amended and extended, or pursuant to a final decision by any
1476 court of competent jurisdiction, whichever first occurs.

1477 BE IT FURTHER RESOLVED, That the Joint Legislative Committee
1478 on Compilation, Revision and Publication of Legislation is hereby
1479 directed to see to it that Section 3 of this resolution is placed
1480 in the editor's notes that follow Section 5-1-1, Mississippi Code
1481 of 1972.

1482 BE IT FURTHER RESOLVED, That if any paragraph, sentence,
1483 clause, phrase or any part of Section 3 of this resolution is
1484 declared to be unconstitutional or void or if for any reason is
1485 declared to be invalid or of no effect, the remaining paragraphs,
1486 sentences, clauses, phrases or parts thereof shall be in no manner
1487 affected thereby but shall remain in full force and effect.

1488 BE IT FURTHER RESOLVED, That this concurrent resolution shall
1489 be considered a joint resolution for the purposes of Section 254
1490 of the Mississippi Constitution of 1890.

1491 BE IT FURTHER RESOLVED, That the Chairman of the House of
1492 Representatives Apportionment and Elections Committee, with the
1493 assistance of counsel employed by the Standing Joint Legislative
1494 Committee on Reapportionment, is hereby directed to submit Section
1495 3 of this resolution, immediately upon its adoption by both houses
1496 of the Legislature, to the Attorney General of the United States
1497 or to the United States District Court for the District of
1498 Columbia in accordance with the provisions of the Voting Rights
1499 Act of 1965, as amended and extended.

1500 BE IT FURTHER RESOLVED, That the foregoing provisions of
1501 Section 3 of this resolution shall take effect and be in force
1502 from and after the date it is finally effectuated under Section 5
1503 of the Voting Rights Act of 1965, as amended and extended, only if
1504 a concurrent resolution redistricting the Mississippi Senate is



1505 finally effectuated under Section 5 of the Voting Rights Act, as
1506 amended and extended.

1507 **FURTHER AMEND** the title by striking the period on line 3 and
1508 inserting in lieu thereof the following:

1509 "; TO REDISTRIBUTE THE MISSISSIPPI STATE SENATE AND THE HOUSE OF
1510 REPRESENTATIVES OF THE STATE OF MISSISSIPPI IN ACCORDANCE WITH
1511 SECTION 254, MISSISSIPPI CONSTITUTION OF 1890; AND FOR RELATED
1512 PURPOSES."
