HOUSE BILL NO. 405

- AN ACT TO AMEND SECTION 85-7-503, MISSISSIPPI CODE OF 1972, TO CLARIFY THE DEFINITION OF "COMMERCIAL REAL ESTATE" UNDER THE
- 3 COMMERCIAL REAL ESTATE BROKER LIEN ACT REGARDING ITS USE FOR
- 4 MULTIFAMILY RESIDENTIAL PURPOSES; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 85-7-503, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 85-7-503. As used in this article, the following terms have
- 9 the following meanings:
- 10 (a) "Broker" means a real estate broker licensed
- 11 pursuant to Section 73-35-3(1).
- 12 (b) "Broker services" means services for which a
- 13 license issued by the Mississippi Real Estate Commission is
- 14 required under Section 73-35-1 et seq.
- 15 (c) "Commercial real estate" means any real property or
- 16 any and every interest or estate in land, including leaseholds,
- 17 timeshares and condominiums, whether corporeal or incorporeal,
- 18 freehold or nonfreehold, but excluding oil, gas or mineral leases
- 19 and any other mineral leasehold, mineral estate or mineral

- 20 interest of any nature whatsoever, which at the time the property
- 21 or interest is made the subject of an agreement for broker
- 22 services:
- 23 (i) Is lawfully used primarily for sales, office,
- 24 research, institutional, warehouse, manufacturing, industrial or
- 25 mining purposes or for multifamily residential purposes involving
- 26 five (5) or more dwelling units; or
- 27 (ii) May lawfully be used for any of the purposes
- 28 listed in this paragraph (c) by a duly enacted zoning ordinance or
- 29 which is the subject of an official application or petition to
- 30 amend the applicable zoning ordinance to permit any of the uses
- 31 listed in this paragraph (c) which is under consideration by the
- 32 government agency with authority to approve the amendment; or
- 33 (iii) Is in good faith intended to be immediately
- 34 used for any of the purposes listed in this paragraph (c) by the
- 35 parties to any contract, lease, option or offer to make any
- 36 contract, lease, or option.
- 37 (d) "Compensation" means any compensation that is due a
- 38 broker for performance of broker services.
- 39 (e) "Lien claimant" means a broker claiming a lien
- 40 under this article.
- 41 (f) "Owner" means the owner of record of any interest
- 42 in commercial real estate.
- 43 **SECTION 2.** This act shall take effect and be in force from
- 44 and after its passage.
