## SENATE CONCURRENT RESOLUTION NO. 606

A CONCURRENT RESOLUTION RECOGNIZING AND COMMENDING THE
DEDICATED PUBLIC SERVICE OF TATE COUNTY ECONOMIC DEVELOPMENT
FOUNDATION CITIZEN OF THE YEAR WAYNE CROCKETT ON THE OCCASION OF
HIS RETIREMENT AS TATE COUNTY CHANCERY CLERK AND FOR 28 YEARS OF
COURTHOUSE SERVICE.

- 6 WHEREAS, for the last 28 years, Wayne Crockett has been a
- 7 fixture at Tate County court offices in downtown Senatobia,
- 8 Mississippi. The longtime Chancery Clerk, who has served since
- 9 1999, has announced his retirement effective December 31; and
- 10 WHEREAS, born in Thyatira, Crockett, the son of Leroy and
- 11 Genevieve Crockett, was raised in Independence and attended
- 12 Independence High School (IHS), where he was named Mr. IHS, Best
- 13 Athlete, and Most Handsome. After high school, Crockett took
- 14 courses at Northwest Mississippi Community College, the University
- 15 of Mississippi and Mississippi State University. He eventually
- 16 returned to Tate County and began a 27-year career with Chromcraft
- 17 as a tool and die maker; and
- 18 WHEREAS, a 28-year Tate County Courthouse veteran, Crockett
- 19 followed in his father's footsteps when it came to serving his

- 20 county. His father put in 24 years as a County Supervisor,
- 21 serving as President for many of those years; and
- 22 WHEREAS, Wayne Crockett first spent 12 years as both the
- 23 county's Property Assessor and Tax Collector before he was elected
- 24 as the county's Chancery Court Clerk in 1999. After 16 years in
- 25 that position, he is not running for reelection; and
- 26 WHEREAS, Crockett certainly succeeded in improving the level
- 27 of efficiency and convenience provided to the public upon taking
- 28 up his courthouse duties. In order to accommodate factory workers
- 29 who many times only had their lunch break to get errands done,
- 30 Crockett began keeping the courthouse open during the lunch hour.
- 31 Other improvements during his tenure: combining all Senatobia and
- 32 Coldwater taxes with county taxes so the courthouse could be a
- 33 one-stop-shop for citizens; mailing out renewal cards for car tags
- 34 and tax statements so taxpayers would know how much they owed
- 35 before coming to the courthouse to pay; and began collecting
- 36 delinquent taxes for Senatobia, along with those he collected for
- 37 the county. As if he did not have enough on his plate as Chancery
- 38 Clerk, Crockett has also been Secretary for the Tate County Board
- 39 of Supervisors, County Treasurer, County Auditor, and has been
- 40 appointed by the court to tend to financial and health decisions
- 41 of a number of individuals in the community; and
- WHEREAS, Wayne Crockett was honored as the Tate County
- 43 Economic Development Foundation's (EDF) Citizen of the Year at the

- 44 EDF's Annual Banquet, March 2, 2015, at the Haraway Center on the
- 45 Northwest Community College Campus; and
- 46 WHEREAS, Crockett, a Looxahoma resident, is married to
- 47 Shirley, and they have two children, Billy and Beth; three
- 48 grandchildren: Nathan, Nick and Leigh; and two
- 49 great-grandchildren, Gabriel and Hallie. Crockett is a longtime
- 50 member of the Rotary Club and of Mt. Vernon United Methodist
- 51 Church. In his free time, he said he can be found helping his son
- 52 tend to his cattle. When asked what he has loved about residing
- 53 in Tate County all these years, he said it all comes down to
- 54 history. "My family settled in Tate County, and I just feel like
- 55 Tate County is a big part of who I am"; and it is with great pride
- 56 that we pay tribute to a wonderful example for public servants,
- 57 with a record of achievement and a legacy of leadership and
- 58 dedication to all in Tate County and in the State of Mississippi:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 60 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 61 we do hereby recognize and commend the dedicated public service of
- 62 Wayne Crockett on the occasion of his retirement as Tate County
- 63 Chancery Clerk and for 28 years of courthouse service, and extend
- 64 to Wayne and his family the best wishes of the Legislature for
- 65 future success.
- BE IT FURTHER RESOLVED, That this resolution be presented to
- 67 Tate County Chancery Clerk Wayne Crockett, forwarded to the Tate

- 68 County Board of Supervisors, and made available to the Capitol
