SENATE CONCURRENT RESOLUTION NO. 655

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, INTRODUCTION, CONSIDERATION
3 AND PASSAGE OF A BILL ENTITLED "AN ACT TO AMEND SECTIONS 37-101-1,
4 37-101-2, 37-101-3, 37-101-5, 37-101-7, 37-101-9, 37-101-11,
5 37-101-13, 37-101-15, 37-101-16, 37-101-19, 37-101-21, 37-101-23,
6 37-101-27, 37-101-28, 37-101-29, 37-101-30, 37-103-1 AND
7 37-103-25, MISSISSIPPI CODE OF 1972, TO PROVIDE RESPONSIBILITY FOR
8 THE ADMINISTRATION OF THE STATE UNIVERSITY SYSTEM ESTABLISHED
9 UNDER THE MISSISSIPPI CONSTITUTION OF 1890, TO PROVIDE FOR THE
10 SELECTION OF THE BOARD OF GOVERNORS OF THE STATE UNIVERSITY SYSTEM

17 POWERS AND DUTIES, TO PROVIDE FOR THE SELECTION OF UNIVERSITY
18 PRESIDENTS AND PRESCRIBE THEIR POWERS AND DUTIES; AND FOR RELATED
19 PURPOSES."
