HOUSE BILL NO. 904

AN ACT TO AUTHORIZE THE UNIVERSITY OF MISSISSIPPI MEDICAL
CENTER, WITH THE APPROVAL OF THE BOARD OF TRUSTEES OF STATE
INSTITUTIONS OF HIGHER LEARNING, TO LEASE A CERTAIN PORTION OF ITS
PROPERTY THAT IS LOCATED IN THE CITY OF JACKSON, MISSISSIPPI, FOR
A TERM OF NO MORE THAN 40 YEARS; AND FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** (1) The University of Mississippi Medical Center

- 8 (UMMC), with the approval of the Board of Trustees of State
- 9 Institutions of Higher Learning, is authorized to enter into an
- 10 agreement to lease a part of its real property to the American
- 11 Cancer Society for the purpose of providing temporary housing to
- 12 cancer patients and their families and for the use of associated
- 13 administrative office space for a term of no more than forty (40)
- 14 years. The property is located in the City of Jackson, Hinds
- 15 County, Mississippi, such parcel to be leased to be more
- 16 particularly described in the agreement as determined by the
- 17 University of Mississippi Medical Center and approved by the Board
- 18 of Trustees of State Institutions of Higher Learning.

- 20 than one (1) successive term of twenty (20) years.
- 21 (3) The lease of the real property described in subsection
- 22 (1) of this section shall consist of an American Cancer Society
- 23 Hope Lodge and an associated office building, which, at a minimum
- 24 contain:
- 25 (a) Approximately eight thousand (8,000) square feet of
- 26 office space;
- 27 (b) Approximately twenty-four thousand (24,000) square
- 28 feet of lodging space containing approximately thirty-five (35)
- 29 temporary residential units;
- 30 (c) Surface parking; and
- 31 (d) Landscaping and green space buffers.
- 32 (4) The lease and any amendments to the lease shall be
- 33 subject to the approval of the Board of Trustees of State
- 34 Institutions of Higher Learning.
- 35 (5) All proceeds derived or received from all leases entered
- 36 into under this section shall be deposited in a special fund for
- 37 the use and benefit of the University of Mississippi Medical
- 38 Center.
