HOUSE BILL NO. 1347

AN ACT TO ESTABLISH A "TROOP X TROOPER SCHOOL REVOLVING FUND" 1 2 TO BE ADMINISTERED BY THE MISSISSIPPI DEPARTMENT OF PUBLIC SAFETY; 3 TO PROVIDE THAT UNUSED FUNDS APPROPRIATED TO THE MISSISSIPPI 4 DEPARTMENT OF PUBLIC SAFETY FOR SALARIES AS A RESULT OF THE 5 RETIREMENT, TERMINATION OR RESIGNATION OF A TROOPER PRIOR TO THE 6 END OF THE FISCAL YEAR SHALL BE DEPOSITED ON AN ANNUAL BASIS INTO 7 THE FUND AND EXPENDED FOR THE SUPPORT AND MAINTENANCE OF THE TROOPER SCHOOL; TO PROVIDE THAT CERTAIN FUNDS MAY BE TRANSFERRED 8 9 BY THE GOVERNOR FROM THE TROOPER SCHOOL FUND IN EMERGENCY SITUATIONS INTO OTHER BUDGET CATEGORIES OF THE DEPARTMENT OF 10 11 PUBLIC SAFETY; AND FOR RELATED PURPOSES.

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 13 SECTION 1. (1) There is hereby established in the State Treasury a "Troop X Trooper School Revolving Fund" to be 14 15 administered by the Mississippi Department of Public Safety to provide funds for the support and maintenance of the trooper 16 school operated by the department. The fund shall consist of 17 18 lapsed funds appropriated to the department for salaries of troopers which are available at the end of the fiscal year due to 19 the retirement, resignation, death or termination of a trooper 20 21 prior to the end of the fiscal year. The Commissioner of Public 22 Safety with the approval of the State Treasurer shall transfer the

23 appropriate amount of lapsed funds under this subsection (1) to 24 the Troop X Trooper School Revolving Fund at the end of each 25 fiscal year, and the State Treasurer shall invest such funds in 26 the same manner as other state funds are invested.

27 (2)At such time as the Troop X Trooper School Revolving 28 Fund balance is sufficient, the fund shall be transferred to the proper account to defray the expense of operation of the trooper 29 school. Any such transfers shall be made under direction of the 30 31 Commissioner of Public Safety with the approval of the State Fiscal Officer and shall only be utilized to fund the expense of 32 33 operation of the trooper school. In the event of an emergency, 34 the Governor is authorized to transfer not exceeding 2.5% of the 35 balance of the Troop X Trooper School Revolving Fund to be used 36 for other budgets of the Mississippi Department of Public Safety. Any transfers made under this subsection (2) shall be submitted to 37 38 the State Fiscal Officer who shall notify the Legislative Budget 39 Office of such action. It is the intent of the Legislature to utilize this fund as often as necessary to train and graduate 40 41 smaller classes of Mississippi Highway Safety Patrol troopers to 42 keep the allotted number of troopers at a constant level.

43 SECTION 2. This act shall take effect and be in force from 44 and after July 1, 2016.
