1 2 3	AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI STATE BOARD OF PSYCHOLOGY FOR THE FISCAL YEAR 2017.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	Treasury to the credit of the Mississippi State Board of
8	Psychology, for the purpose of defraying the expenses of the board
9	for the fiscal year beginning July 1, 2016, and ending
10	June 30, 2017\$ 124,668.00.
11	SECTION 2. It is the intention of the Legislature that the
12	Mississippi State Board of Psychology shall maintain complete
13	accounting and personnel records related to the expenditure of all
14	funds appropriated under this act and that such records shall be
15	in the same format and level of detail as maintained for Fiscal
16	Year 2016. It is further the intention of the Legislature that
17	the agency's budget request for Fiscal Year 2018 shall be
18	submitted to the Joint Legislative Budget Committee in a format

- 19 and level of detail comparable to the format and level of detail
- 20 provided during the Fiscal Year 2017 budget request process.
- 21 **SECTION 3.** It is the intention of the Legislature that
- 22 whenever two (2) or more bids are received by this agency for the
- 23 purchase of commodities or equipment, and whenever all things
- 24 stated in such received bids are equal with respect to price,
- 25 quality and service, the Mississippi Industries for the Blind
- 26 shall be given preference. A similar preference shall be given to
- 27 the Mississippi Industries for the Blind whenever purchases are
- 28 made without competitive bids.
- 29 **SECTION 4.** Of the funds appropriated under the provisions of
- 30 this act, an amount not to exceed Eighty Thousand Two Hundred
- 31 Sixty-eight Dollars (\$80,268.00) shall be expended for
- 32 professional board management fees.
- 33 **SECTION 5.** It is the intention of the Legislature that the
- 34 funds herein appropriated shall be expended in compliance with
- 35 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 36 shall incur obligations or indebtedness in excess of their
- 37 appropriation and that the responsible officers, either personally
- 38 or upon their official bonds, shall be held responsible for
- 39 actions contrary to this provision.
- 40 **SECTION 6.** The money herein appropriated shall be paid by
- 41 the State Treasurer out of any money in the State Treasury to the
- 42 credit of the proper fund or funds as set forth in this act, upon
- 43 warrants issued by the State Fiscal Officer; and the State Fiscal

- 44 Officer shall issue his warrants upon requisitions signed by the
- 45 proper person, officer or officers, in the manner provided by law.
- 46 **SECTION 7.** This act shall take effect and be in force from
- 47 and after July 1, 2016; and shall stand repealed from and after
- 48 June 30, 2016.
