## HOUSE BILL NO. 1667

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE  
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF SPECIAL FUNDS  
3 PREVIOUSLY APPROPRIATED FOR CONSTRUCTION AND/OR REPAIR AND  
4 RENOVATION PROJECTS AT VARIOUS STATE AGENCIES AND INSTITUTIONS,  
5 FOR FISCAL YEAR 2017.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much thereof as may be  
8 necessary, is reappropriated out of any money in the State  
9 Treasury to the credit of Fund No. 3393100000, to the Department  
10 of Finance and Administration, acting through the Bureau of  
11 Building, Grounds and Real Property Management, for the purpose of  
12 reauthorizing the expenditure of funds previously appropriated for  
13 construction and/or repair and renovation projects at various  
14 state agencies and institutions, as authorized in House Bill No.  
15 1562, Regular Session of 2015, for the fiscal year beginning July  
16 1, 2016, and ending June 30, 2017.....  
17 .....\$ 14,940,487.00.

18 This reappropriation is made for the purpose of reauthorizing  
19 the expenditure of special funds for construction and/or repair



and renovation projects at various state agencies and institutions that had been authorized by the Legislature in prior fiscal years.

Notwithstanding the amount reappropriated under the provisions of this section, in no event shall the amount expended exceed the unexpended balance as of June 30, 2016, or change the purpose for which the funds were originally authorized.

**SECTION 2.** The following sum, or so much thereof as may be necessary, is reappropriated out of any money in any special fund in the State Treasury to the credit of Fund 3390200000, to the Department of Finance and Administration, acting through the Bureau of Building, Grounds and Real Property Management, as authorized in SB 2902, 2014 Regular Session, and SB 2896, 2013 Regular Session, for the fiscal year beginning July 1, 2016, and ending June 30, 2017.....\$2,130,201.00.

This reappropriation is made for the purpose of reauthorizing the expenditure of Special Funds previously appropriated by the Legislature in prior fiscal years for construction and/or repair and renovation projects at various state agencies and institutions.

Notwithstanding the amount reappropriated under the provisions of this section, in no event shall the amount expended exceed the unexpended balance as of June 30, 2016, or change the purpose of which the funds were originally authorized.

**SECTION 3.** The following sum, or so much thereof as may be necessary, is reappropriated out of any money in any special fund

50 This reappropriation is made for the purpose of reauthorizing  
51 the expenditure of Special Funds previously appropriated by the  
52 Legislature in prior fiscal years for construction and/or repair  
53 and renovation projects at the Institutions of Higher Learning and  
54 Community and Junior Colleges and various state agencies and  
55 institutions.

56 Notwithstanding the amount reappropriated under the  
57 provisions of this section, in no event shall the amount expended  
58 exceed the unexpended balance as of June 30, 2016, or change the  
59 purpose of which the funds were originally authorized.

60 **SECTION 4.** The Bureau of Building, Grounds and Real Property  
61 Management of the Office of General Services is expressly  
62 authorized and empowered to receive, budget and expend any state,  
63 local or other source funds designated for supplemental funding of  
64 construction and/or repair and renovation projects.

65 **SECTION 5.** The money herein appropriated shall be paid by  
66 the State Treasurer out of any money in the State Treasury to the  
67 credit of the proper fund or funds as set forth in this act, upon  
68 warrants issued by the State Fiscal Officer; and the State Fiscal



69 Officer shall issue his warrants upon requisitions signed by the  
70 proper person, officer or officers, in the manner provided by law.

71       **SECTION 6.** This act shall take effect and be in force from  
72 and after July 1, 2016; and shall stand repealed from and after  
73 June 30, 2016.
