HOUSE BILL NO. 298

1 AN ACT TO AUTHORIZE HOME SCHOOLED STUDENTS TO PARTICIPATE IN 2 EXTRACURRICULAR ACTIVITIES IN THEIR RESPECTIVE SCHOOL DISTRICTS; 3 TO REQUIRE THOSE STUDENTS TO ADHERE TO THE SAME RULES AND 4 REGULATIONS GOVERNING THE PARTICIPATION IN EXTRACURRICULAR 5 ACTIVITIES BY STUDENTS IN THE LOCAL SCHOOL DISTRICT; TO PROHIBIT A 6 LOCAL SCHOOL BOARD FROM IMPOSING ANY REQUIREMENT UPON A HOME 7 SCHOOLED STUDENT FOR PARTICIPATION IN AN EXTRACURRICULAR ACTIVITY 8 WHICH IS NOT IMPOSED UPON FULL-TIME STUDENTS OF THE LOCAL PUBLIC 9 SCHOOL DISTRICT; TO AUTHORIZE THE STATE BOARD OF EDUCATION TO PROMULGATE RULES AND REGULATIONS GOVERNING POLICIES IMPLEMENTED BY 10 11 LOCAL SCHOOL BOARDS PERMITTING THE PARTICIPATION OF HOME SCHOOLED 12 STUDENTS IN EXTRACURRICULAR ACTIVITIES; AND FOR RELATED PURPOSES. 13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 14 SECTION 1. (1) A student who is being educated in a legitimate home instruction program, as defined under the 15 16 Mississippi Compulsory School Attendance Law (Section 37-13-91), 17 may participate in any extracurricular activities available to 18 students in the home schooled student's grade in the local school of the school district where that student resides. Upon the 19 20 request of the home schooled student's parent, guardian or legal 21 custodian, the local school board shall register the student in a public school for purposes of participating in an extracurricular 22 23 activity or activities. 24 within the attendance boundaries of the school in which the 25 student is seeking registration and must submit the request for registration before the deadline established by the local district 26 for participation in the extracurricular activity in the following 27 school year. As used in this section, the term "extracurricular" 28 29 means any school-authorized or education-related activity occurring during or outside the regular instructional school day 30 31 including, but not limited to, academic teams, athletics, art, 32 band, choir, honor societies, music and theatre.

33 (2)A home schooled student participating in any 34 extracurricular activity and his or her parents must adhere to the 35 same rules and regulations adopted by the local school board 36 governing participation in that activity by students in the local 37 Each local school board shall adopt a policy governing school. 38 home schooled student participation in extracurricular activities, 39 which policy must conform to any rules and regulations adopted by 40 the State Board of Education under subsection (3) of this section. However, a local school board may not impose any requirements on a 41 42 home schooled student auditioning for or participating in 43 extracurricular activities which are not imposed on full-time 44 students of the local public school district. When selection to participate in an extracurricular activity at a local public 45 school is made on a competitive basis, a home schooled student is 46 eligible to try out for and participate in the activity as 47 authorized under this section. 48

(3) The State Board of Education may promulgate any rules and regulations as it may deem necessary to promote consistency of policies implemented by local school boards throughout the state permitting home schooled students to participate in extracurricular activities as provided under subsections (1) and (2) of this section.

(4) This section may not be construed to require any home
schooled student to register with a school district for
extracurricular activity purposes.
