HOUSE BILL NO. 694

1 AN ACT TO AMEND SECTION 27-19-56.72, MISSISSIPPI CODE OF 1972, TO REVISE THE DISTRIBUTION OF FEES COLLECTED FROM THE 2 3 ISSUANCE OF DISTINCTIVE MOTOR VEHICLE LICENSE TAGS TO MEMBERS OF 4 THE MISSISSIPPI ASSOCIATION OF REALTORS; AND FOR RELATED PURPOSES. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 SECTION 1. Section 27-19-56.72, Mississippi Code of 1972, is amended as follows: 7 8 27-19-56.72. (1) Any owner of a motor vehicle, who is a 9 member of the Mississippi Association of Realtors, upon complying 10 with the motor vehicle laws relating to registration and licensing 11 of motor vehicles, and upon payment of the road and bridge 12 privilege taxes, ad valorem taxes and registration fees as 13 prescribed by law for private carriers of passengers, pickup 14 trucks and other noncommercial motor vehicles, and upon payment of 15 an additional annual fee in the amount provided in subsection (3), 16 shall be issued a special license tag which displays the blue and gold REALTOR trademark logo on the left side of the license tag. 17 The distinctive license tags so issued shall be of a color and 18 19 design as the Department of Revenue, with the advice of the

23 Application for the special license tag shall be made to (2)24 the county tax collector on forms prescribed by the Department of 25 Revenue. Proof of membership in the Mississippi Association of Realtors shall be presented to the county tax collector at the 26 27 time of the application. An applicant's personal business card on 28 which the REALTOR trademark logo is also printed shall be accepted 29 as proof of membership in the Mississippi Association of Realtors. 30 The application and the additional fee, less Two Dollars (\$2.00) thereof to be retained by the tax collector, shall be remitted to 31 32 the Department of Revenue on a monthly basis as prescribed by the department. The portion of the additional fee retained by the tax 33 34 collector shall be deposited into the county general fund.

35 (3) Beginning with any registration year commencing on or 36 after July 1, 2003, any person applying for a distinctive tag under this section shall pay an additional fee in the amount of 37 38 Thirty Dollars (\$30.00) for each distinctive license tag applied 39 for under this section, which shall be in addition to all other 40 taxes and fees. The additional fee shall be for a period of time to run concurrently with the vehicle's established license tag 41 42 vear. The additional fee is due and payable at the time the original application is made for distinctive license tags under 43 this section and thereafter annually at the time of renewal 44

No. 694 ~ OFFICIAL ~ 17/HR26/R881 PAGE 2 (BS\KW) 45 registration as long as the owner retains the distinctive license 46 If the owner does not wish to retain the distinctive license tag. tag or is no longer affiliated with the Mississippi Association of 47 Realtors, he must surrender it to the local county tax collector. 48 49 (4) The Department of Revenue shall deposit all fees into 50 the State Treasury on the day collected. At the end of each month, the Department of Revenue shall certify the total fees 51 collected under this section to the State Treasurer who shall 52 53 distribute such collections as follows:

54 (a) Except as otherwise provided in this paragraph (a), Twenty-four Dollars (\$24.00) of each additional fee collected on 55 56 special license tags issued pursuant to this section shall be 57 distributed to Mississippi Association of Habitat for Humanity 58 Affiliates, Inc., for use in funding affordable housing projects 59 in Mississippi. However, from and after July 1, 2017, Twenty-four 60 Dollars (\$24.00) of each additional fee collected on such special 61 license tags issued pursuant to this section shall be distributed to the Mississippi REALTOR® Disaster Relief Fund. 62

(b) One Dollar (\$1.00) of each additional fee collected
on special license tags issued pursuant to this section shall be
deposited into the Mississippi Burn Care Fund created pursuant to
Section 7-9-70.

(c) Two Dollars (\$2.00) of each additional fee
collected on special tags issued pursuant to this section shall be
deposited to the credit of the State Highway Fund to be expended

(d) One Dollar (\$1.00) of each additional fee collected on distinctive license tags issued pursuant to this section shall be deposited to the credit of the special fund created in Section 27-19-44.2.

(5) A regular license tag must be properly displayed as required by law until replaced by a distinctive license tag under this section. The regular license tag must be surrendered to the tax collector upon issuance of the distinctive license tag under this section. The tax collector shall issue up to two (2) license decals for each distinctive license tag issued under this section, which will expire the same month and year as the license tag.

83 In case of loss or theft of a distinctive license tag (6) issued under this section, the owner may make application and 84 85 affidavit for a replacement distinctive license tag as provided in 86 Section 27-19-37. The fee for a replacement distinctive license tag shall be Ten Dollars (\$10.00). The tax collector receiving 87 88 such application and affidavit shall be entitled to retain and 89 deposit into the county general fund five percent (5%) of the fee 90 for such replacement license tag and the remainder shall be 91 distributed in the same manner as funds from the sale of regular distinctive license tags issued under this section. 92

93 SECTION 2. This act shall take effect and be in force from 94 and after July 1, 2017.
