HOUSE BILL NO. 1585

AN ACT TO AMEND SECTION 51-35-333, MISSISSIPPI CODE OF 1972, 1 2 TO PROVIDE THAT IF THE BOARD OF DIRECTORS OF A DISTRICT FORMED 3 UNDER THE URBAN FLOOD AND DRAINAGE CONTROL ACT DETERMINES THAT A 4 FLOOD OR DRAINAGE CONTROL PROJECT WILL BENEFIT ONLY A PORTION OF 5 THE DISTRICT, THE BOARD MAY LEVY SPECIAL ASSESSMENTS ON THE 6 PROPERTY SO BENEFITED TO PAY CERTAIN COSTS RELATED TO SUCH 7 PROJECT; TO PROVIDE FOR THE COLLECTION OF SUCH ASSESSMENTS; TO 8 PROVIDE THAT PRIOR TO LEVYING SUCH A SPECIAL ASSESSMENT, THE BOARD 9 OF DIRECTORS OF THE DISTRICT SHALL MAKE A DETERMINATION THAT THE 10 NECESSARY APPROVALS AND AUTHORIZATIONS ARE IN PLACE AND THAT 11 PROJECT-RELATED ACTIVITIES ARE READY TO COMMENCE; AND FOR RELATED 12 PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** Section 51-35-333, Mississippi Code of 1972, is amended as follows: 51-35-333. (1) (a) To provide funds for the payment of the

17 principal of, interest on, and other charges in connection with 18 bonds issued under the provisions of this article, to provide funds for the annual expenses of operations of the district, and 19 20 to provide funds for carrying out any of the purposes of this 21 article, the district is empowered to levy annually a special tax 22 upon all the taxable property within such district on or before 23 the first Monday of September of each year and shall certify the H. levy to the boards of supervisors of the various counties in * * *
the district. It shall be the duty of the boards of supervisors
of each county to make * * * the levy on each tract of land or
other property in * * * the district according to the assessed
valuation thereof.

29 *** * *** (b) The taxes shall be collected by the tax collectors of the respective counties in * * * the district, who 30 31 shall deposit them in such depository as shall be selected by the 32 board of directors of the district. The tax collector shall 33 receive a sum not greater than one-fifth of one percent (1/5 of)34 1%) of the amount collected for his services in making such collection, and * * * the fee shall be paid into the county 35 36 general fund. It shall be the duty of the board of directors to 37 levy a tax sufficient to pay the bonds and the interest thereon as such bonds and interest become due, to pay for the annual expense 38 39 of operation of the district, and to provide funds for carrying 40 out any of the purposes of this article.

41 (2) (a) If the board of directors undertakes a flood and
42 drainage control improvement project that the board determines
43 will benefit only a portion of the district:

(i) The board of directors may levy a special improvement assessment that applies only to property in the district that is directly or indirectly benefited by the project to provide funds for the payment of costs related to the flood and drainage control improvement project, including the payment of

49 costs related to the principal and interest on any bonds issued 50 under this article for the project and any related expenses; and 51 (ii) The board of directors may levy a special 52 improvement maintenance assessment that applies only to property 53 in the district that is directly or indirectly benefited by the 54 project to provide funds for the operation, maintenance and 55 preservation of the project. 56 (b) Prior to levying an assessment under this 57 subsection, the board of directors shall make a determination that 58 the necessary approvals and authorizations are in place and that 59 project-related activities are ready to commence. (c) If an assessment is levied under this subsection, 60 61 the board of directors shall annually determine, order and levy 62 the annual installment of the total assessments. These 63 assessments may be due and collected during each year that county 64 taxes are due and collected, in which case the annual installment 65 and levy shall be evidenced to and certified to the county tax 66 assessor by the board of directors not later than the first Monday 67 of September of each year. The assessments shall be entered by 68 the assessor on the county tax rolls and shall be collected and 69 enforced by the county tax collector in the same manner and at the 70 same time as county taxes, and the proceeds thereof shall be paid 71 to the district. These assessments shall be a lien on the 72 property against which assessed until paid and shall be 73 collectible and enforceable in like manner as county property

74	taxes. All statutes regulating the collection and enforcement of
75	county property taxes shall apply to the enforcement and
76	collection of the assessments levied under this subsection. The
77	amount of the assessments under this subsection shall be
78	determined by the board of directors and assessed by the board of
79	directors upon such lands, which may be part or all of the lands
80	within the district benefited by the project, apportioned between
81	benefited lands in proportion to the benefits received by each
82	tract of land.
83	(d) The tax collector shall be entitled to reasonable
84	compensation for collecting the assessments which shall be not
85	greater than one-fifth of one percent (1/5 of 1%) of the amount
86	collected for his services in making such collection, and the fee
87	shall be paid into the county general fund.
88	SECTION 2. This act shall take effect and be in force from
89	and after July 1, 2017.
