SENATE BILL NO. 3015

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF GENERAL FUNDS,
 2 CAPITAL EXPENSE FUNDS, AND SPECIAL FUNDS TO DEFRAY THE EXPENSES OF
 3 THE DEPARTMENT OF FINANCE AND ADMINISTRATION FOR FISCAL YEARS 2017
 4 AND 2018; THE OFFICE OF THE GOVERNOR-DIVISION OF MEDICAID FOR
 5 FISCAL YEAR 2017 and 2018; TO MAKE APPROPRIATIONS FROM THE BUDGET
 6 CONTINGENCY FUND FOR THE DEPARTMENT OF MARINE RESOURCES; TO MAKE
 7 APPROPRIATIONS FROM THE GULF COAST RESTORATION FUND FOR THE
 8 DEPARTMENT OF MARINE RESOURCES AND FOR RELATED PURPOSES; AND FOR
 9 RELATED PURPOSES.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

11 **SECTION 1.** In addition to all other sums herein
 12 appropriated, the following sum, or so much thereof as may be
 13 necessary, is appropriated out of any money to the credit of the
 14 Capital Expense Fund, to defray the expenses of the Department of
 15 Finance and Administration for the period beginning upon the
 16 passage of this act and through June 30, 2018....\$9,649,689.00.

17 This additional appropriation is made for the purpose
 18 of purchasing property insurance on state property as
 19 required by the Stafford Act, Section 311, Paragraph 5154
 20 and 44 CFR 206.252 and 206.253, and for defraying



21 additional costs of the Department of Finance and
22 Administration.

23 **SECTION 2.** In addition to all other sums herein
24 appropriated, the following sum, or so much thereof as may be
25 necessary, is appropriated out of any money to the credit of the
26 Department of Finance and Administration, to defray the expenses
27 of the Department of Finance and Administration for the period
28 beginning upon passage of this act and through the fiscal year
29 ending June 30, 2018.....\$ 4,068,585.00.

30 This additional appropriation is made for the purpose of
31 defraying additional costs of the Department of Finance and
32 Administration.

33 **SECTION 3.** In addition to all other sums herein
34 appropriated, the following sum, or so much thereof as may be
35 necessary, is appropriated out of any money to the credit of the
36 General Fund, to defray the expenses of the Office of the
37 Governor-Division of Medicaid for the period beginning upon
38 passage of this act and through the fiscal year ending June 30,
39 2017.....\$ 40,000,000.00.

40 This additional appropriation is made for the purpose of
41 supporting the operations of the Office of the Governor-Division
42 of Medicaid.

43 **SECTION 4.** In addition to all other sums herein
44 appropriated, the following sum, or so much thereof as may be
45 necessary, is appropriated out of any money to the credit of the



46 Department of Revenue, for the period beginning upon the passage
47 of this act and through the fiscal year ending June 30,
48 2018.....\$ 408,500.00.

49 This additional appropriation is made for the purpose of
50 defraying the expenses incurred by the agency.

51 **SECTION 5.** In addition to all other sums appropriated
52 herein, the following sum, or so much thereof as may be necessary,
53 is appropriated out of any money to the credit of the Budget
54 Contingency Fund, to defray the expenses of the Department of
55 Marine Resources for the period beginning upon the passage of this
56 act and through the fiscal year ending June 30, 2017....\$ 1.00.

57 **SECTION 6.** In addition to all other sums herein
58 appropriated, the following sum, or so much thereof as may be
59 necessary, is appropriated out of any money to the credit of the
60 Gulf Coast Restoration Fund, to defray the expenses of the
61 Department of Marine Resources for the period beginning upon the
62 passage of this act and through the fiscal year ending June 30,
63 2017.....\$ 1.00.

64 **SECTION 7.** This act shall take effect and be in force from
65 and after its passage and through the fiscal year ending June 30,
66 2017, except for Section 1, Section 2, and Section 4, which shall
67 take effect and be in force through the fiscal year ending
68 June 30, 2018.
