- 20 That, as provided for in Article V of the SECTION 1.
- Constitution of the United States, the Legislature of the State of 21
- 22 Mississippi herewith respectfully applies for an Amendments
- 23 Convention to be called for the purpose of proposing an Amendment
- which shall provide that an increase in the federal debt requires 24
- 25 approval from a majority of the Legislatures of the separate
- 26 states.
- 27 SECTION 2. That, as provided for in Article V of the
- 28 Constitution of the United States, the Legislature of the State of
- 29 Mississippi herewith respectfully applies for an Amendments
- 30 Convention to be called for the purpose of proposing an Amendment
- to the Constitution of the United States of America to set a limit 31
- on the number of terms that a person may be elected as a Member of 32
- 33 the United States House of Representatives and to set a limit on
- 34 the number of terms that a person may be elected as a Member of

- 36 SECTION 3. That the Amendments Conventions contemplated by
- 37 Sections 1 and 2 of this application shall be entirely focused
- 38 upon and exclusively limited to the subject matter of proposing
- 39 for ratification Amendment(s) to the Constitution providing that
- 40 an increase in the federal debt requires approval from a majority
- of the Legislatures of the separate states, and an Amendment to 41
- the Constitution providing for Congressional Term Limits. 42

43	SECTION 4. This application shall be considered as covering				
44	the same subject matter as the applications from other States to				
45	Congress to call a Convention (a) placing fiscal limits on the				
46	federal debt, or (b) to set a limit on the number of terms that a				
47	person may be elected to the House of Representatives of the				
48	Congress of the United States and the Senate of the United States				
49	and this application shall be aggregated with same for the purpose				
50	of attaining two-thirds of the Legislatures of the several states				
51	necessary to require Congress to call a limited Convention on				
52	these subjects, but shall not be aggregated with any other				
53	applications on any other subject.				
54	SECTION 5. This application constitutes a continuing				
55	application in accordance with Article V of the Constitution of				
56	the United States until at least two-thirds of the Legislatures o				
57	the several states have made application for an equivalently				
58	limited Amendments Convention.				
59	BE IT FURTHER RESOLVED, That a certified copy of this				
60	application be transmitted by the Secretary of State, to the				
61	President of the United States Senate, to the Speaker of the				
62	United States House of Representatives, to each member of the				
63	applicant's delegation to the United States Congress, and to the				
64	presiding officers of each house of the several state				
65	Legislatures, requesting their cooperation in applying for the				
66	Amendments Convention limited to the subject matters contemplated
