10	SECTION 1. The following sum, or so much of it as may be

13	Secretary of State for the purpose of making distributions to

15	beginning July 1, 2016, and ending June 30, 2017

23	appropriated by Chapter 25, Laws of 2016, that are unexpended as
24	of June 30, 2017, for the same purposes as authorized for
25	expenditures from the Land Records Maintenance Fund, for the
26	fiscal year beginning July 1, 2017, and ending June 30, 2018
27	\$ 1,000,000.00.
28	None of the funds appropriated in this section shall be used
29	for the operations of the Office of the Secretary of State.
30	SECTION 3. The money appropriated by Section 1 of this act
31	shall be paid by the State Treasurer out of any money in the State
32	Treasury to the credit of the Land Records Maintenance Fund, and
33	the money appropriated by Section 2 of this act shall be paid by
34	the State Treasurer out of any money in the State General Fund not
35	otherwise appropriated, upon warrants issued by the State Fiscal
36	Officer; and the State Fiscal Officer shall issue his warrants
37	upon requisitions signed by the proper person, officer or officers
38	in the manner provided by law.
