HOUSE BILL NO. 174

1 AN ACT TO AUTHORIZE AN INCOME TAX CREDIT FOR TAXPAYERS THAT 2 EMPLOY PERSONS WHO HAVE BEEN CONVICTED OF CERTAIN NONVIOLENT 3 CRIMES; TO PROVIDE THE AMOUNT OF THE TAX CREDIT; TO LIMIT THE 4 AMOUNT OF THE TAX CREDIT THAT MAY BE CLAIMED IN A TAXABLE YEAR; 5 AND FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. (1) Subject to the provisions of this section, a 8 taxpayer that employs a person who has been convicted of a felony offense for a nonviolent crime shall be allowed an annual credit 9 10 against the taxes imposed under this chapter. The credit shall be for an annual amount of One Thousand Dollars (\$1,000.00) for five 11 12 (5) years for each person so employed. However, the tax credit 13 shall not exceed the amount of tax imposed upon the taxpayer for the taxable year reduced by the sum of all other credits allowable 14 15 to the taxpayer under this chapter, except credit for tax payments made by or on behalf of the taxpayer. In order to be eligible to 16 17 claim a tax credit for an employee, the taxpayer must employ the employee for at least nine (9) consecutive months during the year 18 19 for which the credit is claimed and the employee must work an

20 average of at least thirty (30) hours per week for the taxpayer 21 during that time. For the purposes of this subsection, the term 22 "nonviolent crime" means and has the same definition as that term 23 has in Section 47-7-3.

(2) The tax credits provided for in this section shall be inaddition to any other credit authorized under law.

26 (3) Any taxpayer who is eligible for the credit authorized 27 in this section before January 1, 2021, shall be eligible for the 28 credit authorized in this section, notwithstanding the repeal of 29 this section.

30 (4) This section shall be repealed from and after January 1,31 2021.

32 SECTION 2. Section 1 of this act shall be codified as a 33 separate section in Chapter 7, Title 27, Mississippi Code of 1972. 34 SECTION 3. This act shall take effect and be in force from 35 and after January 1, 2018.
