HOUSE BILL NO. 179

1 AN ACT TO AUTHORIZE ANY COUNTY BOARD OF SUPERVISORS TO ALLOW 2 THE USE OF COUNTY VEHICLES AND ROAD EQUIPMENT BETWEEN THE VARIOUS 3 DEPARTMENTS OF THE COUNTY IN THE PERFORMANCE OF SUCH OFFICES' 4 DUTIES AND RESPONSIBILITIES WITHOUT THE NECESSITY OF 5 REIMBURSEMENT; TO AUTHORIZE THE TRANSFER OF COUNTY VEHICLES OR 6 ROAD EQUIPMENT BETWEEN VARIOUS DEPARTMENTS OF THE COUNTY FOR A 7 NOMINAL FEE OR WITHOUT THE NECESSITY OF REIMBURSEMENT AS DETERMINED BY THE BOARD TO BE IN THE BEST INTEREST OF THE COUNTY'S 8 9 TAXPAYERS; TO REOUIRE THE BOARD TO SPREAD UPON ITS MINUTES ANY 10 DECISION TO PERMIT THE USE OR TRANSFER OF VEHICLES OR ROAD 11 EQUIPMENT IN THE COUNTY'S FLEET OF VEHICLES; AND FOR RELATED 12 PURPOSES.

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 14 **SECTION 1.** The board of supervisors of any county may authorize the use of county vehicles and road equipment within the 15 16 county's fleet of vehicles by any department of the county without necessity of cost reimbursement from one (1) division of the 17 18 county to another division for such use of vehicles or road equipment in the performance of the duties and responsibilities 19 assigned to such division. Additionally, the board, in its 20 21 discretion, may authorize the transfer of vehicles or road 22 equipment between departments of the county for a nominal amount or without the necessity of cost reimbursement as determined by 23 H. the board to serve the best interest of the taxpayers of the county. However, if the board allows the countywide inter-departmental use or transfer of county vehicles or road equipment, the same shall be spread upon the minutes of the board authorizing such use and the duration thereof or transfer.
SECTION 2. This act shall take effect and be in force from

30 and after July 1, 2018.
