## HOUSE BILL NO. 210

1 AN ACT TO AUTHORIZE LOCAL SCHOOL BOARDS TO EMPLOY LICENSED 2 SOCIAL WORKERS AND LICENSED PSYCHOLOGISTS TO PROVIDE SERVICES TO 3 STUDENTS IN THE PUBLIC SCHOOLS; TO PROVIDE THAT A SCHOOL DISTRICT 4 THAT EMPLOYS AT LEAST ONE SOCIAL WORKER OR PSYCHOLOGIST FOR EVERY 5 ONE THOUSAND STUDENTS ENROLLED IN THE SCHOOLS OF THE DISTRICT IS 6 ELIGIBLE FOR REIMBURSEMENT FOR FIFTY PERCENT OF THE COST OF THE 7 SALARY OF EACH SOCIAL WORKER OR PSYCHOLOGIST FROM THE STATE 8 DEPARTMENT OF EDUCATION; AND FOR RELATED PURPOSES.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 10 SECTION 1. (1) The school board of a school district may 11 employ licensed social workers and licensed psychologists to 12 provide services to students enrolled in and in attendance at the 13 schools of the school district, as determined by the 14 superintendent of the district. The school board shall fix the compensation of a social worker or psychologist employed by the 15 district under this section. 16 17 (2) A school district that employs at least one (1) social worker or psychologist for every one thousand (1,000) students 18 19 enrolled in the schools of the district is eligible for 20 reimbursement for fifty percent (50%) of the cost of the salary of

The superintendent of any school district that is 23 eligible for the reimbursement under this section shall apply to the State Department of Education for the reimbursement in a 24 25 manner prescribed by the department. After receipt of an application for reimbursement and any information that may be 26 27 required by the department, the department shall pay to the school district an amount equal to fifty percent (50%) of the cost of the 28 salary of each social worker and psychologist for whom the 29 30 district is eligible to be reimbursed. In making reimbursements to school districts for employing social workers and 31 32 psychologists, the department may use any funds specifically made available for that purpose. 33

34 SECTION 2. This act shall take effect and be in force from 35 and after July 1, 2018.
