HOUSE BILL NO. 223

AN ACT MAKING AN APPROPRIATION TO THE DEPARTMENT OF FINANCE
AND ADMINISTRATION FOR THE PURPOSE OF CONDUCTING A STUDY OF
CERTAIN ASPECTS OF THE ALCOHOLIC BEVERAGE INDUSTRY AND THE
OPERATIONS OF THE ALCOHOLIC BEVERAGE CONTROL DIVISION FOR THE
FISCAL YEAR 2019.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** The following sum, or so much of it as may be
- 8 necessary, is appropriated out of any money in the State General
- 9 Fund not otherwise appropriated, to the Department of Finance and
- 10 Administration for the purpose of conducting a study of certain
- 11 aspects of the alcoholic beverage industry and the operations of
- 12 the Alcoholic Beverage Control Division of the Department of
- 13 Revenue as provided in Section 2 of this act for the fiscal year
- 14 beginning July 1, 2018, and ending June 30, 2019....\$ 75,000.00.
- 15 **SECTION 2.** With the funds appropriated under Section 1 of
- 16 this act, the Department of Finance and Administration shall
- 17 contract with a third party to conduct a study and make
- 18 recommendations to the Legislature for the 2019 Regular Session on
- 19 the following:

- 21 than five percent (5%) of alcohol by weight in retail food stores
- 22 would have on the Alcoholic Beverage Control Division (ABCD) with
- 23 regard to the increased demand for wine and the effect on

- 25 (b) The current operations of the ABCD and recommended
- 26 modifications to the ABCD system to improve capacity and supply
- 27 for permit holders, improve the process for issuing permits,
- 28 placing orders and making reports to the ABCD, and increase the
- 29 points of shipment for orders.
- 30 **SECTION 3.** The money appropriated by this act shall be paid
- 31 by the State Treasurer out of any money in the State General Fund
- 32 not otherwise appropriated, upon warrants issued by the State
- 33 Fiscal Officer; and the State Fiscal Officer shall issue his
- 34 warrants upon requisitions signed by the proper person, officer or
- 35 officers in the manner provided by law.
- 36 **SECTION 4.** This act shall take effect and be in force from
- 37 and after July 1, 2018.
